While the transition to semesters has created a flurry of new work for all of us, it also presents us with promising new opportunities. This session will highlight such opportunities as they emerge through the process of review and redesign of courses and curricula. We begin by exploring concepts that guide course redesign so as to make the most of these new opportunities, such as backwards design and Bloom's taxonomy. We then move on to consider such areas of faculty attention and concern as the syllabus, the 3-2 sequence conversion, and bridge courses. Such structural frameworks can facilitate new ways of conceptualizing, and we invite others to describe their own experiences within these processes of redesign.

Everyone affirms that effective academic advising is critical to successfully transition our students from the quarter to semester calendar. This session portrays how two institutions are developing interactive academic advising tools that advisors and students will actually enjoy using, even after Fall 2012. Marion Technical College and Infinum Education, LLC, have partnered to create the next generation of "smart" advising software called MAPS that advances advisor-advisee collaboration to attain a new level of certainty and assurance for students. Rhodes State College have developed an "Advising Suite" that provides access to: a) interactive tools that link students and advisors; b) student advising records by multiple advisors; c) degree audit; and (d) an e-educational plan that enables tracking of student progress for honoring Our Pledge to Students.

The Semester Conversion Challenges for Graduate Education

Some may suggest that graduate education has been, at best, the tail of semester conversion or, in the worst case scenario, a somewhat forgotten component of conversion processes. This may only be natural in conversion processes premised on an undergraduate calendar charting a four year road to a degree and the need to protect all facets of the "student experience." Graduate education, however, particularly doctoral education, marches to a different calendar, one that is less focused on a coursework progression but, rather, one tied to the student's own research training and advancement and, as well, critical issues of funding and support. Such concerns, and others, make the challenges of semester conversion in graduate education a somewhat different enterprise than the transitions necessary in the world of undergraduates. The nature of such challenges will be the focus of this interactive session.
