Dear Dean Slotnik,

As graduate studies chair for the Department of Art Education, I am requesting that the Graduate School formally recognize those students successfully completing the requirements for a Graduate Program Specialization in Museum Education and Administration. We have piloted this museum education strand for the past six years, and after refining the curriculum and course mix, now feel prepared to move forward with marketing a Graduate Program Specialization in Museum Education and Administration.

Graduate students in both our Art Education MA and Ph.D. programs of study and those within the Arts Policy and Administration Program have identified the value of having such a specialization noted on their transcripts. This recognition of their having completed the requirements for this specialization may more competitively position them on the job market. The range of pilot participants' professional placement and advancements affirms the appeal and value of this course of study, with alumni now working in higher education, major museum settings, and in development and management positions. This designation can increase the department's ability to attract mid-career arts professionals, as it will be one of the only Ph.D. degree programs with a Museum Specialization in the United States.

Our Graduate Program Specialization in Museum Education and Administration offers students opportunities to deeply explore the social and cultural role of the museum as an institution, and critically examine its past, present and potential trajectories and contributions in the 21st century. The overall goal of Graduate Program Specialization in Museum Education and Administration is to provide a broad introduction to the museum as a social institution, an educational destination, a site of both cultural transformation and continuity, and as a professional career opportunity. Students in this specialization will be well prepared to work within museums, use museums in their teaching, advance the work of museums, and recognize the policies and social practices that shape them. This approach distinguishes this specialization from the many technical preparation programs in museum education.
