Dear Chair and Members of the Arts and Sciences Curriculum Committee:

On January 10, 2025, the Arts and Humanities Subcommittee 2 reviewed a request from the Department of Art Education to revise the MA in Art Education.

The revision was based on a curricular review by the department's Digital Learning Committee and included student feedback over the years. Through this review, the department recognized that the population currently served by the program goes beyond art teachers (for whom it was originally designed) and now includes those who are "pursuing alternative forms of art education including museum- and community settings." The proposed revisions (summarized below) are an effort to better respond to the program's more diverse student population:

- The addition of ARTEDUC 7708 (Universal Design for Learning: Disability Studies and Art Education) as a required course (vs. its current role as a 6-wk elective)
- A reduction in the *overall* number of *required courses* for greater curricular flexibility (from 18 ch to 12 ch)
- The expansion of the number of electives (from 6 ch to 12 ch)

Please note that the overall number of credit-hours in the MA remains the same and the department has a plan to ensure that students already in the program will not be effectively negatively by these changes.

A&H Subcommittee 2 voted unanimously to approve the request with three contingencies. Those items have since been addressed by the unit and the proposal is now advanced to the ASCC with a motion to approve.

Program Change: Online MA Program in Art Education

I am writing to request a change in our current plan of study for the Online MA in Art Education. Our Department's Digital Learning Committee reviewed the Online MA program curriculum and course offerings as well as student feedback over the past year. One of the main findings from student feedback was a desire for ARTEDUC 7708: Universal Desing for Learning: Disability Studies and Art Education to be a full-semester required course rather than a sixweek elective as well as more elective options addressing issues related to community arts and museum education. While the program was initially designed for practicing art teachers, more students are pursuing alternative forms of art education including museum and community settings. Subsequently, we would like to reduce the number of required courses to create space for the inclusion of more elective courses throughout the year. This change will address scheduling needs as well as provide a more robust curriculum for our students. Finally, this change will draw the Online MAAE program plan of study into better alignment with the oncampus MAAE program plan of study, which has fewer required courses and more elective/specialization courses.

Our current requested changes to the plan of study include:

- 1. Adding ARTEDUC 7708: Universal Design for Learning: Disability Studies and Art Education to our existing plan of study (3 credit hours) as a required course.
- Removing ARTEDUC 7604: Teaching of Studio Activities (3 credit hours), ARTEDU 7607: Curriculum and Assessment in Art Education (3 credit hours), and ARTEDU 7777: From Research to Advocacy (3 credit hours) from our existing plan of study. Please note that these courses will continue to be offered as elective options.

Elective courses will be offered on a two-year rotation (five courses across three semesters per rotation), and required courses will be offered yearly. Students who have matriculated prior to the plan of study change will have the option of using the old plan of study. Course offerings for 2025-2026 will ensure these students can complete the previous plan of study whether they are on the full- or part-time plan. Students who take a leave of absence will be required to complete the program under the most current plan of study. This plan of study change will take effect Autumn 2025.
