Dear Chair and Members of the Arts and Sciences Curriculum Committee:

On January 13, 2025, the Social and Behavioral Sciences Subcommittee reviewed a request from the Department of Psychology approve a change to an existing minor in psychology, to be effective in Autumn 2025. This minor (currently called "General Psychology Minor") will be retitled as "Psychology Minor" and will then become the only minor available in Psychology. The other six minors that currently exist in the department will be phased out by Spring 2028.

The proposed revised Psychology Minor will remove the requirement of Psychology 2220, remove a core areas requirement, remove an advanced course requirement, and add a course level requirement. The revised minor will require 15 credit hours, a prerequisite of Psychology 1100, Psychology 2300, and 12 additional credit hours of psychology courses at the 2000-level or higher (with at least six of those hours at the 3000-level or higher).

The department writes that the current General Psychology Minor has significantly more students than the combination of the other six minors. The department states that this change will "increase access to the minor" as well as "offer more flexibility for students to design a minor program that best fits their interests and goals." In addition, the new structure will "more easily allow the integration of new areas within the field of psychology." The department will guide students in designing their minor by creating suggested pathways as well as through individual advising.

Students who are in the minors being phased out will be permitted to stay in those minors or switch to the new minor. These students also will receive regular communication and guidance from the department regarding deadlines and other details.

The SBS Subcommittee voted unanimously to approve this request, with three contingencies. Those contingencies have been addressed, and the proposal is now advanced to the ASCC with a motion to approve.

Dear Social and Behavioral Sciences Subcommittee:

Thank you for your review and feedback on our submission of a revision to the Psychology minor. Our faculty have reviewed the feedback and responded below to the reviewing faculty's concerns and questions.

1. The Subcommittee notes that the requirement of Psych 2220: Data Analysis in Psychology has been eliminated in this revision, but the rationale for this particular change has not been provided. The reviewing faculty understand the effort to condense the credit hours in the process of moving to one minor, but there is concern regarding the removal of a course that was required and clearly essential to the programs. There is also concern that eliminating this requirement will limit the courses students can take at the 4000-level and above due to prerequisites, therefore reducing rather than increasing course flexibility. The Subcommittee requests clarification regarding this change, including its impact on course options.

Originally, the General Psychology Minor was conceptualized as a "mini" version of the major, which requires Data Analysis (Psychology 2220); hence, we maintained this requirement for students pursuing the psychology minors. However, over time, we have come to the conclusion that the minor actually serves a different function for students. Given psychology's role as a hub science and the increasing recognition of the importance of mental health, there is a need for an option that gives students wide exposure to the content of psychological science and helps them develop skills as consumers of psychological science without the need for designing and conducting independent research. Removing the requirement for Data Analysis allows wider access to these important skills. Moreover, students must complete the equivalent of college algebra or Statistics 1450 as a prerequisite for Psychology 2220. In our proposal, students who have chosen to take other courses to fulfill their Mathematical and Quantitative Reasoning GE will still have the psychology minor available to them.

Additionally, we want to emphasize that any student completing the minor can still choose to take Psychology 2220, particularly if they're interested in an advanced courses for which it is a prerequisite.

2. The Subcommittee requests an explanation of the statement on the first page of the proposal that "courses will only count on the minor if prerequisite coursework has been successfully completed ahead of time". They are uncertain whether this can be retroactively enforced, as there are several courses (e.g., GEN Themes courses Psych 2303 and 2311) that could apply to the minor but do not have the Psych 1100 prerequisite. The Subcommittee is unclear on how this policy will be applied and if exceptions will be made.

This prerequisite policy will not be retroactively enforced and only applies to courses which have prerequisites. In this case, since Psychology 2303 and Psychology 2311 do not have any prerequisites, the policy does not apply to them.

3. The Subcommittee asks for more detailed reasoning regarding the decision to eliminate all six of the existing Psychology minors. Given that the department has a substantial student population and that many of the minors are well-attended, the Subcommittee would appreciate more information on how the decision to fully eliminate rather than retain certain options will serve students.

Moving to one minor simplifies the process and is more student-centered. Frequently, students reach out to request exceptions to their minor program, typically due to inflexibility within their major programs, particularly in programs with clinicals or student teaching. By opening up the entire psychology curriculum as options to students completing the minor, we anticipate removing the need for exceptions, as well as disappointing fewer students who are unable to complete the minor in their final semester due to scheduling issues. Importantly, we plan to provide students with clusters of classes that might be particularly useful for specific career goals or academic trajectory. For example, for students interested in a career in applied psychology, we would suggest one cluster of classes and for students interested in a career in business, we would suggest another cluster of classes. We believe that removing the requirements associated with existing minors while maintaining suggested pathways that are related to the existing minors provides the most student-centered, flexible, and useful minor format.

Dear Arts and Sciences Curriculum Committee,

The Department of Psychology currently offers seven minors, listed by name below along with the current number of students who have declared each minor (see Appendix 1 for current minor advising sheets). We propose to change the name and some of the requirements of our General Psychology Minor, effective AU25. Once the proposal has been approved, we will phase out the other six minors.

- 1. Biological Bases of Behavior (16 students)
- 2. Clinical Psychology and Individual Differences (44 students)
- 3. Developmental Psychology (45 students)
- 4. General Psychology (286 students)
- 5. Organization and Performance (29 students)
- 6. Psychology Research (6 students)
- 7. Social Psychology and Personality (40 students)

We propose to change the name of the minor from General Psychology to Psychology Minor. The requested curricular changes from the General Psychology to the Psychology Minor are:

- 1. Remove requirement of Psychology 2220
- 2. Remove core areas requirement
- 3. Remove advanced course requirement
- 4. Add course level requirement

Once approved, the Psychology Minor will require (see Appendix 2 for the proposed minor advising sheet):

- 1. 15 credit hours
- 2. Prerequisite: Psychology 1100 (not included in minor credit hours)
- 3. Psychology 2300
- 4. 12 additional credit hours of psychology courses at the 2000-level or higher
 - a. At least six of the 12 additional credit hours must be at the 3000-level or higher
- 5. Courses will only count on the minor if all prerequisite coursework has been successfully completed ahead of time.

The proposed changes will not only increase access to the minor but will also offer more flexibility for students to design a minor program that best fits their interests and goals, as well as more easily allow the integration of new areas within the field of psychology.

While some students appreciate the specificity of the distinct seven minor options, over 100 more students have opted for the General Psychology Minor than in all the other minors combined. By moving

to one minor and offering more flexibility and choice in coursework, students will have more opportunity to design a minor program with an emphasis that supports their goals and interests. To support students in planning a minor curriculum, we will provide suggested pathways on our website. Appendix 3 shows suggested pathways for students interested in pre-health, law, education, and business. We will continue to build out additional suggested pathways, and students can also meet with a psychology advisor if they have questions about other suggested paths.

Once the Psychology Minor goes into effect in AU25, the six other minors will be phased out. The proposed phase out date for the six minors is after SP28, allowing current first-year students to complete them. However, we will keep a close eye on students completing the separate minors, and if all of the students who have declared the minor graduate earlier than SP28, we will move up the phase out term.

Current minor program students across the six minors being phased out will have the option to continue in their current minor, or they may elect to switch to the Psychology Minor. Students in the current General Psychology Minor will be switched to the Psychology Minor, which will permit additional flexibility over the current General Psychology Minor requirements. Students new to the university in AU25 and beyond and those who have not yet declared the minor will only have the option to choose the Psychology Minor beginning in AU25.

Once the minor change is approved, we will communicate with students who have declared the General Psychology Minor about the change and the additional flexibility in the minor requirements. For students who have declared any of our six minors being phased out, we'll communicate the following information to them:

- 1. Information about the change
- 2. Deadline to complete their current minor
- 3. Details of the Psychology Minor and how to switch to this minor if they prefer

After the initial communication, we will email declared students midway through both autumn and spring semesters, reminding them of the changes and of the deadline to complete the legacy minors.

Thank you for your consideration of our proposed minor change. Please let me know if I can provide any additional information to support your review.
