Dear Vice Provost Smith,

The College of Dentistry is proposing to add an International Dentist track (IDT) to the predoctoral dental (DDS) program. Dentists who have graduated from dental programs outside the U.S. would be eligible to apply for this track. Students in this track would enter the predoctoral dental program with advanced standing and start in the spring semester of the second year of the four-year predoctoral dental program. Thus, students in the International Dentist track would complete the final 7 academic terms of the predoctoral dental program. The curriculum for the International Dentist track would be the same as for the predoctoral dental program with the addition of one course that would educate students with procedures and materials that they may not be familiar with from their international dental programs. The track would begin with an additional 4 students, but grow to include entering cohorts of 8 students, increasing the number of dentists graduating from Ohio State and entering the workforce each year.

The proposed changes include:

- Creating an International Dentist track that would start in spring semester of the second year of the predoctoral dental program.
- Add one dental course for students in this track, focused on dental procedures and materials used in the predoctoral dental program but that international dentists might not have experience with using.

With careful consideration and support from the College of Dentistry's DDS Curriculum Committee, Executive Committee, Division Chairs, and Dean Trotman, the International Dentists track will help the College align with the university's goal of workforce development.

RE: International Dentist Track in the Predoctoral Dental Program

Introduction: Proposal to Establish an Advance Standing International Dentist Track to the DDS Program

The Ohio State University College of Dentistry proposes the establishment of an International Dentist Track (IDT) within its Doctor of Dental Surgery (DDS) program to provide a pathway for internationally trained dentists to earn U.S. licensure. This 28-month advanced standing curriculum integrates IDT students into the existing DDS program beginning in the spring semester of the second year, allowing them to complete the final seven academic terms. The program will launch with a small cohort and scale up to admitting eight students annually. In addition, the IDT is expected to generate significant tuition revenue, support workforce development in Ohio communities, and strengthen the college's competitive position among peer institutions.

Background

The proposal to establish an International Dentist Track (IDT) within the predoctoral DDS program at The Ohio State University College of Dentistry is rooted in the institution's commitment to global engagement, educational excellence, and addressing workforce needs in oral health care.

The rationale for the IDT is multifaceted:

Global Engagement: The program will expand the college's international footprint by welcoming qualified dentists from around the world, enriching the educational environment with wide-ranging perspectives and experiences.

Educational Experience: By welcoming internationally trained dentists into the DDS program, the College of Dentistry will enhance the educational experience by broadening students' exposure to global perspectives and professional practices. This

integration supports the development of professional competencies that prepare students to serve a wide range of patient populations.

Workforce Development: The IDT offers a strategic solution to the shortage of dental professionals in Ohio and the U.S. By enabling internationally trained dentists to earn U.S. credentials, the program may increase the number of dentists serving underserved communities. By retaining international graduates in Ohio, the program may help address regional dentist shortages and improve access to care in underserved communities. Nationally, there are 7,054 dental health professions in shortage areas (DHPSA). Ohio has 162 of these shortage areas, including areas in Franklin County.^{1,2}

Institutional Reputation: The presence of international students and graduates will enhance the college's visibility and reputation globally, potentially attracting future students, faculty, and research collaborators.

International Dentist Track Development

Development of the proposal involved a comprehensive review of existing International Dentist Programs across the U.S., particularly within peer institutions and Big Ten universities—seven of which already offer similar tracks. The College consulted resources from the American Dental Education Association (ADEA), including data from the Centralized Application for Advanced Placement for International Dentists (CAAPID), which reported over 3,100 applicants in the 2023–2024 cycle.

Additional steps in the proposal's development included:

- Benchmarking tuition models, admissions criteria, and curriculum structures from other programs.
- Engaging with directors and academic leaders from established IDPs at institutions such as the University of Minnesota, University of North Carolina, and Rutgers University.
- Gathering feedback from internal stakeholders, including faculty and staff, to assess the potential impact and integration of international students into existing clinical and academic settings.
- Evaluating fiscal implications and identifying revenue opportunities through tuition, application, and interview fees.

This proposal reflects a strategic and well-researched initiative that positions the College of Dentistry to lead in international dental education and contribute meaningfully to the oral health workforce.

The development of the International Dentist Track (IDT) at The Ohio State University College of Dentistry is informed by a comprehensive review of similar programs across peer institutions nationally. Comparative analysis reveals that many U.S. dental schools

have already implemented International Dentist Programs (IDPs), underscoring the relevance and competitiveness of this initiative.

National Landscape

- 40 of 69 accredited dental schools in the U.S. and Puerto Rico currently offer IDPs.
- Among these, 10 of the Big Ten dental schools have established IDPs, positioning Ohio State to align with its peer institutions.

Applicant Demand

- According to the American Dental Education Association (ADEA) CAAPID data from the 2023–2024 cycle:
 - 3,143 applicants submitted a total of 25,645 applications to IDPs nationwide.
 - The top countries of dental degree origin include India, Pakistan, Venezuela, Cuba, and Egypt.
 - The top U.S. states where applicants currently reside are Florida,
 California, Texas, New York, and New Jersey.

Peer Engagement

- The College consulted with IDP directors and academic leaders at institutions such as:
 - University of Minnesota
 - University of North Carolina
 - Rutgers University
- These consultations provided insights into curriculum integration, student support, and program outcomes.

This comparative data supports the feasibility and strategic value of launching an IDT at Ohio State, ensuring the program is competitive, responsive to national trends, increasing the dental workforce and care available to Ohioans, and aligned with best practices in international dental education.

The implementation of the International Dentist Track (IDT) within the DDS program will involve a series of strategic actions and will have implications—both positive and challenging—for various stakeholders across the College of Dentistry and the broader university community.

Impact on Constituencies

 Faculty: Faculty members will be engaged in teaching and mentoring IDT students, particularly in the newly developed clinical competency course. This

- may require adjustments in instructional approaches to accommodate varied educational backgrounds and clinical experiences.
- Students (Graduate and Undergraduate): DDS and dental hygiene students will benefit from exposure to global perspectives and practices, enhancing their understanding of global oral health. However, integration may require additional support to ensure cohesive clinical teams and equitable learning experiences.
- Staff: Administrative staff will manage increased application volume, interview logistics, and student support services. This may necessitate hiring additional personnel or reallocating existing resources.
- Alumni: Alumni may view the program as a positive step toward global engagement and workforce development. Opportunities for alumni involvement in mentoring or networking may arise.
- Accrediting Organizations: The program will be designed to meet all accreditation standards, with documentation and curricular adjustments submitted for review and approval to the Commission on Dental Accreditation (CODA).

Internal Programmatic Changes

- Introduction of one new course tailored to IDT students with didactic and preclinical laboratory experiences (Appendix B).
- Adjustment of clinical schedules and group assignments to integrate IDT students starting in the second year of the DDS program.
- Development of orientation and curricular programming and academic support tailored to the needs of internationally trained dentists.

Impact Beyond the College

- University-Wide Effects: The program may increase international visibility and contribute to broader university goals related to global engagement and professional education. Additionally, this program aligns the college with other dental colleges throughout the country.
- No Overlap in Scope: The proposal does not overlap in scope or substance with other academic units. However, collaboration with the Office of International Affairs and other support units (e.g., admissions, student services) will be essential for successful implementation.

Admission

Admission to the IDT Program will require the following materials to be submitted by candidates:

Dental Degree Transcripts

- Test of English as a Foreign Language (TOEFL) minimum score of 90
- Passing score on the INDBE or Part 1 and 2 NBDE
- Letters of Recommendation
- Interview
- Bench skill test
- CV
- Written personal statement

Admission is selective and competitive and applications will be managed by the college admissions office in conjunction with the Grad and Professional Admissions office and the ADEA CAAPID application service. The program would enroll four students in the inaugural class in spring 2027 and eight students each subsequent year.

Curriculum

A comprehensive view of the curriculum for the IDT is outlined in Appendix A. The DDS degree is 178 hours. The IDT will accept 71 hours from the student's international dental program and require 107 hours to complete the DDS degree.

Assessment Plan

The assessment plan for the IDT track will remain similar to the DDS degree, with slight modifications to adjust for some differences in the two tracks. For example, students in the IDT will have already had to pass the INDBE exam upon entering the program, so that measure will not be used for students on this track.
