RE: CLARIFICATION OF CURRICULUM CHANGE FOR COUNSELOR EDUCATION PHD PROGRAM

#### Dear Colleagues,

Thank you for this opportunity to address any areas of confusion about the proposed changes to the PhD program in Counselor Education in the College of Education and Human Ecology. Recall that the rationale for these additional credits is to meet our accreditation standards that all PhD students must have at least 60 credits post-Masters starting in 2026. In the documents of this email you will find two additional documents: the original specialization sheet with track changes, and the clean specialization sheet that shows all the changes. Below I will enumerate the changes in order that they appear on the track-changes specialization sheet.

- 1. Program Requirements: 61 hours
- 2. The Research Core courses are clarified so that students take 2 courses in one methodological tradition and at least 1 course from the other methodological tradition. These courses are listed for students' reference. Additional verbiage on page 2 related to Research is removed.
- 3. The Minimum hours post MA/MS is also corrected to read 61 hours.
- 4. Specialization Requirements equal 28 hours, which is 12 hours of Required Content Courses and 16 hours of Supervised Internship in Counselor Education.
  - a. The Required Content Courses are four courses for 12 hours. All deleted courses are gone.
  - b. The Supervised Internship in Counselor Education is 16 hours. The .01, .02, etc., extension of the course number is gone. The Internship class will be taken for 4 credits per semester for 4 semesters.
  - c. The Recommended Electives are gone as those credits have been moved to the Cognate.



- 5. The Cognate Area is now 12 hours and is presented more clearly.
- 6. The Dissertation Requirement is now 6 hours.

I hope that this clarifies the intent of the change to the PhD program so that it will be easily understandable for all students in the program.

Please find materials included in this proposal related to the revision of the PhD Educational Studies – Counselor Education specialization program. The department wishes to add 10 credits to the total program hours, split between an increase in the Research (three credits), Internship (four credits), and Cognate requirements (three credits). This increases the total program hours from 51 to 61 and is a percentage change of 19.61%.

Dr. Collette Dollarhide, the program contact, stated the following regarding a transition plan for students currently in the program: "For doctoral students who are continuing their programs, their requirements will not change. In keeping with the program in existence upon their admission, we will continue to offer the classes and maintain course/credit requirements they knew upon their admission. For doctoral students starting in Fall 2026, as mandated by CACREP, our learned body, these new requirements will begin once approved through the system."

Dr. Dollarhide also stated the following regarding any potential changes to learning goals, program objectives, or assessment plans: "The learning goals, program objectives, and assessment plan will not change for the PhD program. The change in the number of credits is in response to accreditation requirements for credit hours."

The EHE Curriculum Committee unanimously approved this revision on September 19, 2024.

Dear Colleagues,

We have program adjustments we are proposing to our Master's program (both tracks) and our PhD program in Counselor Education. Below you will find the rationale for each program change and references to all changed documents. Thank you for your consideration; if there are any questions, please feel free to contact Dr. Dollarhide or Dr. Zyromski.

**PROPOSED CHANGES TO MASTER'S PROGRAM, BOTH TRACKS** (School Counseling and Clinical Mental Health Counseling):

Due to instructional needs, we request that the number of credits and related educational time be expanded for ESCE 6737 – Group Counseling. Two years ago, this course was merged from two separate courses (3 credits for theories and 1 credit for practice) into one 3-credit course for 3 hours of instructional time per week. This initial change was made to meet President Johnson's directive to reduce time and credits to graduation. Unfortunately, over the past two years, the instructor for the course found that 3 hours is insufficient time for learning of concepts and theory, *and* practice of group counseling concepts, strategies, and techniques in a group setting with doctoral-level group facilitation and supervision. Expanding the class to 4 credits will allow time for both didactic conceptual learning and experiential group learning, and we hope to be able to offer this 4-hour class in Spring 2025.
