The Medical Laboratory Science (MLS) Division is seeking to update Program and course prerequisites. Below is a brief overview of the rationale for the changes.

Program Prerequisites:

The MEDLBS Program offers students a variety of curriculum track options, each specific course prerequisites that must be met prior to enrolling in a track or completing a course within the program. It has been several years since the prerequisites were reviewed for accuracy, relevance and effectiveness in ensuring success in the program's courses. Upon conducting the review, we identified several changes that would 1) provide additional options for students; and 2) reduce unnecessary courses. Please see the document "Rationale for MEDLBS Program Prerequisite Changes_2025" for further details on updates for each curriculum track and its course prerequisites.

Course Prerequisites:

Like the program prerequisites, the individual course prerequisites were reviewed for accuracy and relevance. Upon conducting the review, we identified changes related towards 1) prerequisite courses; 2) omission of curriculum tracks which would have students enrolled in courses; and 3) omission of an exclusionary clause (we offer courses that may be taken either online or in-person and students may take one or the other, not both).
