Executive Summary: Appalachian and Rural Center for Health (ARCH)

Purpose

The Ohio State University Wexner Medical Center (OSUWMC) is proud to be part of a leading public and land-grant research university with a mission to serve the people of Ohio. The work of OSUWMC is rooted in the university's strategic plan framework, ***Education for Citizenship 2035*** ([link](#)) which is built upon the university motto, "Education for Citizenship" and guides us by three principles:

- *Everything we do must connect with our mission as a land-grant university.*
- *We exist because of and for the people we serve.*
- *We exist to make our state and nation better, and to equip our graduates to do the same.*

Through six themes, the university's strategic framework urges collaboration among faculty, staff, and students across Ohio State's colleges, campuses, and the medical center:

- **Accessibility:** scientific expertise accessible to communities and industry
- **Student Success:** complementing academics with training through internships and student employment; for students across disciplines, involvement in healthcare enterprise
- **Workforce Development:** expand co-ops, internships, and other extracurricular student experiences; utilize scholarship and research to improve the way industry partners operate
- **Outreach and Engagement:** utilize Ohio State scholarship and research to uplift surrounding communities; expand healthcare access to rural communities and families in Ohio and the region
- **Performance Excellence and Resource Stewardship:** bring clinical care to those who need it
- **Service to the State of Ohio:** research that benefits organizations and communities; producing/retaining talent for in-demand fields; improve the health and wellness of families with rural health centers

The medical center's 10-year strategic plan ***Impact 2035*** ([link](#)) is aligned with the university strategic framework through eight priorities. One of those priorities, entitled "A Healthier Ohio," calls for the creation of "*a center to study and improve health outcomes in rural Ohio.*" In pursuit of this, OSUWMC has developed and proposes the **Appalachian and Rural Center for Health (ARCH)** as a new university center. This center will advance "A Healthier Ohio" in Appalachian and rural Ohio communities. We aim to mobilize the

resources and advance the university priorities focused on academics, research and creative expression, and healthcare while also drawing from the talent, culture, and operations to create a center that attracts and cultivates a full range of faculty and staff across OSU devoted the mission of the proposed center.

ARCH's mission is to extend OSU's clinical, educational, and research capacity to rural and Appalachian partners, joining forces to create sustainable healthcare solutions. We enact this mission by improv health outcomes and eliminating health disparities in rural and Appalachian Ohio through a transformational and sustainable **healthcare extension service**. The core efforts of this extension service include:

- Establish and support ongoing long-term trusting partnerships among Ohio State's faculty, staff, and students with healthcare providers and communities across rural and Appalachian Ohio.
- Enhance and maintain the rural and Appalachian healthcare workforce with a goal of achieving equitable access, care and resources.
- Implement innovative and evidence-based clinical programs with local partners by co-creating scalable, community-driven solutions and translating research into practice faster.
- Advance state-of-the-art translational research and implementation science to inform and achieve the mission and goals of ARCH.
- Advocate for the health care interests of rural and Appalachian Ohio with local, state and federal partners.

Together, *Education for Citizenship 2035* and *Impact 2035* provide impetus for the creation of ARCH. The partnership approach mutually reinforces efforts by the Ohio State community and communities throughout Ohio to improve the health of rural and Appalachian Ohioans and make our state and nation better.

Vision

Put hope into action to co-create sustainable healthcare solutions in partnership with local communities to achieve a healthier Ohio.

Mission

Extend OSU's clinical, educational, and research capacity to rural and Appalachian partners, joining forces to create sustainable healthcare solutions.

ARCH is taking an asset-based approach as we develop the OSUWMC healthcare extension service. Focal OSU/OSUWMC assets with a pre-existing presence in Ohio's Appalachian and rural communities include, but are not limited to:

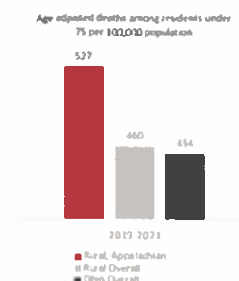
- OSU Extension with its existing presence in all 88 counties and focused programs on health education/promotion.
- Ohio State Health Network and Digital Consult Network which provide administrative and clinical support to over 30 hospitals and health systems in Ohio.
- Referring-hospital relationships that represent 50% of OSUWMC's admissions.
- Clinical and Translational Science Institute, State of Ohio Adversity and Resiliency Study (SOAR), and The James Comprehensive Cancer Center cancer prevention research networks.
- Local community strengths, assets, and subject matter experts.
- Subject matter experts at Ohio State and across the nation focused on community health and healthcare extension services in rural and Appalachian communities.
- Regional campus structure that is well-positioned to partner with local communities on certificate and degree-granting programs.
- OSU degree programs, courses, and organizations aligned with the ARCH mission.

ARCH will center its work on the most pressing opportunities and challenges to advance rural and Appalachian health. Ohio has the 4th largest rural population in the U.S.

- Ohio Ranks 9th in the U.S. for Least Healthy Populations.
- Rural and Appalachian communities face significant health disparities due to limited access to care, infrastructure, and workforce shortages.
- 50% of OSUWMC's inpatient admissions are from outside Franklin County.
- Seven of the top 10 largest employers in Ohio are healthcare systems ([link](#)), and in Appalachian and rural areas of Ohio, healthcare systems are often in the top 1-3 largest employers in their county. Strong healthcare systems are key to local community vitality and economic development.

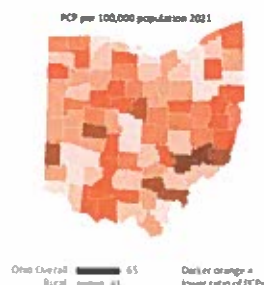
Higher Mortality

Phases of Work

- In FY25:
 - *In the Community:*
 - Worked to develop a strong relationship with individuals and organizations focused on the critical issues related to health in our rural and Appalachian communities.
 - Collaborating with the leadership of the Ohio Rural Health Association culminating in OSU being chosen to host the 2026 Annual Meeting for ORHA at the OSU ATI campus in Wooster.
 - Collaborating with the Foundation for Appalachian Ohio on the development of a new “Growing Health” fellowship to be jointly sponsored by both organizations
 - Meeting with leaders of the Ohio State Health Network member hospitals to begin introducing the concept of healthcare extension in addition to the current work we do with those organizations
 - Meeting with leaders within the Governor’s Office as well as the Ohio Department of Medicaid, Department of Health, Department of Mental Health and Addiction Services, and other state agencies to begin introducing the concept of healthcare extension and the fact that OSUWMC is planning a new commitment focusing on this topic
 - Meeting with Ohio University representatives from the Ohio Alliance for Population Health, College of Health Sciences and Professions, Heritage College of Medicine, and Voinovich School of Leadership and Public Service to keep them informed of our enhanced focus on rural and Appalachian health and desire to collaborate in these shared interests.
 - *Within OSU:*
 - In follow-up to the OSUWMC strategic planning process, key stakeholders across the organization developed and refined the project plan based on the original work done during the development of **Impact 2035**.
 - In parallel, a team of faculty and staff from OSUWMC and the College of Food, Agriculture, and Environmental Sciences (CFAES) Office of OSU Extension co-created a model for healthcare extension in Ohio. They researched healthcare extension and outreach models at other universities. This team included: OSUWMC team members: Dr. Andrew Thomas, M.D., Lori Criss, Ben Anthony, Scott Schroeder and from CFAES David Civittolo, Pat Bebo and Erik Porfeli, Ph.D.

- These efforts culminated in a presentation to the OSUWMC Board in November 2024 that received positive feedback from the Board. This presentation outlined the project's goals that are reflected in this Center application.
 - The OSUWMC team also began regular meetings with the Clinical and Translational Science Institute to collaboratively approach research in rural and Appalachian Ohio and met with the QI HUB for discussions on learning health systems and bringing best practices to scale in Ohio.
 - We held introductory meetings with the Office of Academic Affairs, the OSU Regional Campus Deans, and multiple Deans across the health science colleges to introduce the concept of a healthcare extension program.
 - Through the Executive Sponsor Dr. Andrew Thomas, OSUWMC Chief Clinical Officer, the team proposed a budget for FY26/27 and secured funding beginning July 1, 2025.
 - In late FY25, the team added two new members to focus on program operations and administrative support. A phased approach to hiring will position ARCH to manage these resources, hit key milestones, and build a sustainable organization.
- In FY26:
 - *In the Community:*
 - Meetings began in Q1FY26 with potential Appalachian and rural partners with a goal of finalizing the first three regional partner communities by the end of Q2FY26. Once formalized, the “Discovery” phase that involves the co-creation of local projects is expected to begin in the second half of FY26.
 - *Within OSU:*
 - We continue to refine the model and engage with key OSU partners to ensure that we have a unified plan and message as ARCH is implemented and university center status is pursued.
- In FY27:
 - Continue collaboration with existing partners to implement co-created projects.
 - Enlist two additional regional partners for a total of 5 regions by the end of year 2.
 - The arc of the center’s work will include expanded translational science and the opportunity for health sciences, social work, policy, and other students to learn and work in rural and Appalachian healthcare settings. *Translational science refers to the field focused on the translation of scientific discoveries into practical applications that improve health outcomes.*

Governance

- **Center Sponsor:** John Warner, MD, CEO OSU Wexner Medical Center and Executive Vice President at The Ohio State University
- **OSUWMC Executive Leadership:** Andrew Thomas, MD, Chief Clinical Officer OSU Wexner Medical Center, Senior Associate Vice President for Health Sciences, and Professor of Clinical Internal Medicine
- **Center Director:** Lori Criss, MSW
- **Advisory Boards:** Both internal and external advisory boards are planned to provide the leadership team with strategic guidance and feedback. Faculty involvement will be crucial internal advisors.

Budget & Staffing

- OSUWMC committed \$2.4 million in FY26 and is projected to commit \$3.2 million in FY27.
- ARCH will seek extramural funding from local, state, and federal public and private sources to augment the institutional support.
- We will hire staff in a phased approach across multiple fiscal years in accord with the development of ARCH and based upon its initiatives, funding, and achievement of milestones. In FY26, ARCH aims to have 13.25 FTEs and in FY27 that will increase to 18.00 FTEs.
- Concurrently, we will explore and engage faculty across OSU to advance the goals of ARCH and in alignment with their teaching, research, and service agendas. This may include the buy-down of time from some key faculty to be directly involved in implementing ARCH initiatives.

What Appalachian and Rural Center for Health **will** Do

OSU's Appalachian and Rural Center for Health will ...

- Strengthen partnerships within OSU and with rural and Appalachian communities and others.
- Listen to communities to understand their healthcare needs, community assets and challenges, and innovations they wish to pursue to enhance their OSU and local health care partners.
- Co-create solutions that are sustainable locally, can be scaled regionally or statewide and can inform similar efforts across the nation.
- Explore options for keeping local care through telehealth, digital consultations, and more.
- Foster community-based research that includes research questions generated by the community.
- Support local educational systems and workforce partners in creating pathways for residents into healthcare as a career.
- Provide technical assistance to enhance local care delivery.
- Contribute to advocacy for rural and Appalachian healthcare needs.
- Help convene others with knowledge and passion for designing workable solutions.
- Help pursue grants, look at revenue capture opportunities, create sustainability plans.

What Appalachian and Rural Center for Health **will not** Do

OSU's Appalachian and Rural Center for Health will not ...

- provide major investment for local projects.
- replace locally delivered healthcare services or compete with local providers.
- replace or duplicate local capacity for community planning.
- replace or duplicate local workforce development and higher education efforts.
- impose solutions on communities.
- speak for communities.

I. Mission

The Appalachian and Rural Center for Health (ARCH) exists to extend OSU's clinical, educational, and research capacity to partners in rural and Appalachian Ohio, joining forces to create sustainable healthcare solutions.

Alignment with the University's Mission

The Appalachian and Rural Center for Health's mission echoes The Ohio State University's public, land-grant mission as we work to extend the expertise of the university to support healthcare providers, patients, and communities across the rural and Appalachian parts of Ohio. ARCH will foster a culture of engagement and service that positions our team to advance relationships, deepen partnerships, extend capacity to improve health outcomes in partner communities, and eventually scale solutions regionally or statewide.

Land grant Responsibility: Ohio State University was founded as a land grant university in 1870. Land grant universities were given a three-part mission: to educate residents of the state, to conduct research, and to engage communities across each state to meet their localized needs. OSUWMC is uniquely situated as Ohio's only academic medical center that is also part of a land grant institution.

Born out of Ohio State's land grant mission, OSUWMC's ARCH will be connected to an extensive network of campus-wide relationships, resources, and partners, including OSU Extension through the College of Food, Agriculture, and Environmental Sciences (CFAES) and the Clinical and Translational Science Institute (CTSI) which spans all of OSU's academic campuses. With these foundational elements in place and a strong ambition to create a Healthier Ohio, ARCH is well-positioned to translate clinical and implementation science discoveries into practical, sustainable health solutions in communities across Ohio. From an education perspective, we envision ARCH as a clearinghouse of opportunities for connecting OSU's certificate and degree-granting programs with local healthcare providers and community educational programs to enhance the healthcare workforce in those communities. This collaborative approach, rooted in OSU's land grant mission, is crucial for improving health outcomes and ensuring that the benefits of research and innovation reach the communities that need them.

Interdisciplinary Nature of the Appalachian and Rural Center for Health

The core driver of ARCH is partnerships. Efforts will be aimed at coordinating work among rural and Appalachian communities in Ohio, the OSU community, and other stakeholders

through our Healthcare Extension service to enhance the health and vitality of rural and Appalachian communities.

Partnerships at OSU: To achieve the vision of ARCH, we are building bridges to the remarkable work already underway within the university community on the Columbus and regional campuses related to the health of Appalachian and rural communities. While not all of this ongoing work will report up to ARCH, we envision the Center serving as an entity to better align work being done across these regions as well as a connector for new opportunities on these topics. This is particularly important for translational science research, healthcare extension, workforce development, and innovative care delivery.

Healthcare Extension: The OSU Extension-OSUWMC partnership has been critical to moving a model of healthcare extension forward in Ohio. Since early 2024, OSUWMC and OSU Extension have been working collaboratively to create a model for healthcare extension. Core to the growth of this partnership have been faculty and staff from both organizations.

- OSU Extension had representation on the OSUWMC strategic planning workgroup for the center for rural and Appalachian Health.
- A small work group formed to stand up a novel approach to system level clinical extension that meshes with OSU Extension's Consumer and Family Services health education in local communities.
- This combined OSU Extension-OSUWMC team reviewed literature, met with others working in health extension around the country, and drafted a structure and approach to healthcare extension that is the centerpiece of ARCH's work.
- This partnership is moving from planning to implementation, emphasizing coordination among OSU Extension and ARCH for community presence, co-creation of solutions, and long-term efforts to improve health outcomes across Ohio.

Key to the creation of the healthcare extension is OSUWMC's hiring of **Healthcare Extension Agents**. These team members will be residents of the community or region being served. The Healthcare Extension Agent serves as a bridge between Ohio State University and local communities to advance community-centered health initiatives. This role emphasizes co-creation, advocacy, and partnership-building, connecting OSU's academic and clinical resources with community needs. Embodying trustworthiness and fostering it among partners is a primary responsibility of the Healthcare Extension Agent. Duties include integrating into the community, facilitating collaboration, maintaining open and transparent communication, and staying attuned to evolving local needs. Each agent's

role is shaped by the community they serve, requiring adaptability, inclusivity, and a commitment to meaningful, action-oriented work. Agents function as catalysts for health promotion, workforce development, and clinical transformation.

Translational and Implementation Science Research: The Clinical and Translational Science Institute (CTSI) has a host of activities that OSU can partner with to advance the health of rural and Appalachian Ohioans including:

- Data resources and AI,
- Study design,
- Trial implementation support,
- Regulatory support,
- Grant writing support, and
- Funding resources.

Coordinated work across the Health Science Colleges and CTSI will bring the robust research expertise of OSU to ARCH's efforts to partner in research efforts with rural and Appalachian communities with a focus on the translation of scientific discoveries into practical applications that improve health outcomes.

Innovative Care Delivery: Partners in this work will include researchers, practitioners, existing community engagement staff to assist healthcare providers and institutions across Appalachian and rural Ohio in standing up innovative clinical programs to tackle difficult clinical problems like maternal and infant health, mental health, addiction, chronic disease management, and nutrition/obesity.

- This work will leverage clinical staff across OSUWMC and The James Comprehensive Cancer Center (TJCCC), Health Science colleges, Ohio State Health Network (OSHN), CTSI, State of Ohio Adversity and Resiliency (SOAR) Study, and Care Innovation and Community Improvement Program (CICIP) (in partnership with the Ohio Department of Medicaid).
- Through engagement with OSUWMC's care delivery teams and researchers, we will find key services shown to get positive outcomes for patients and staff, document those practices in "playbooks" for innovative care delivery and offer those "playbooks" and technical assistance to partnering healthcare organizations for sustainable local care redesign.

Workforce Development and Retention: Building and maintaining the healthcare workforce delivering care in Appalachian and rural communities across Ohio will be key to ARCH's success in improving healthcare outcomes.

- ARCH will partner with a variety of OSU colleges and regional campuses and other

educational partners to support growth of educational opportunities to increase the healthcare training and workforce opportunities in and near rural and Appalachian communities including both degree-granting and certificate programs.

- ARCH will also partner with the OSUWMC human resources team to identify recruitment and retention practices that could be replicated with partners.

ARCH Operations: As ARCH grows in scale and complexity of operations, we plan to remain efficient and cost-effective by not replicating support resources that are already available in the institution. This will also have a positive impact on alignment of ARCH's mission with that of the rest of OSUWMC and OSU.

- Internally, ARCH will rely on partners across OSUWMC and OSU for assistance with strategic planning, communication, government relations, technology and AI, data, and quality improvement.
- These partnerships will also leverage data provided through the Government Resource Center (GRC), CHRR, and strategies being employed by the OSUWMC Office of Health Equity.

Rural and Appalachian Internal Network: Through the Rural and Appalachian Internal Network (RAIN), ARCH will engage individual OSU faculty, staff, and students with professional or personal ties to rural and Appalachian Ohio.

- RAIN will foster an environment to share the work of ARCH with those interested in Appalachian and rural health including research results, educational strategies, volunteer and internship opportunities, and other life experiences.
- We believe that RAIN will increase participation and investment of faculty, staff, and students in the work and outcomes of ARCH both on and off campus across Ohio.
- RAIN will also be an effective tool to better engage the leadership of service organizations across the university as well as the Alumni Association and other externally focused groups in the work of ARCH.
- Finally, RAIN will provide a platform for idea generation, feedback, and participation in workstream implementation.

Goals that Cannot be Easily Achieved in Any One Academic Unit

The Appalachian and Rural Center for Health aims to:

- Build and establish long-term trusting partnerships with healthcare providers and rural and Appalachian communities across Ohio.

- Enhance rural and Appalachian healthcare workforce to achieve equitable access, care and resources.
- Implement innovative and evidence-based clinical programs with local partners by co-creating scalable, community-driven solutions and translating research into practice faster.
- Advance innovative translational research to inform and achieve the mission and goals of ARCH.
- Advocate for the health care interests of rural and Appalachian Ohio with local, state and federal partners.

Even with all of the work being done on Appalachian and rural health within the university, these goals for the Center would be difficult to accomplish in any one academic unit due to the scale, scope and complexity of the work. ARCH is focused on our ability to create effective and sustainable partnerships with local communities across the Appalachian and rural parts of the state.

Collaboration with Community Organizations: ARCH will rely on input from community partners to inform its work. Community partners will include residents of rural and Appalachian Ohio, people with experience in providing and receiving medical care in rural and Appalachian Ohio, local and state government and policy groups, public health and public behavioral health groups, community-based organizations, philanthropy, research, and other technical experts. These partners will be engaged through the various workstreams of the center: community partnership, workforce development and retention, innovative care delivery, research, and advocacy. Healthcare Extension Agents who are residents of the local community and employees of OSUWMC will function as trusted liaisons between local communities and the university's health sciences, colleges, research, and extension systems. This role is modeled after the OSU Extension tradition and informed by national best practices in health extension.

Rural and Appalachian Communities: In year 1, ARCH will identify 3-4 partnering communities as our inaugural communities. Partnership efforts will be broad and inclusive across these communities, extending to local hospitals, safety net providers, primary care providers, Federally Qualified Health Centers (FQHCs) and Rural Health Centers (RHCs), community-based organizations, local public health and public behavioral health organizations, locally elected leaders, educational institutions, faith leaders, businesses, and employers.

We recognize that healthcare is often one of the largest employment categories in rural and Appalachian regions. Health outcomes also have a tremendous impact on the health of the local economy and the ability of employers to effectively staff their businesses. OSUWMC will serve as a partner/facilitator extending its clinical, teaching, and research capacity for local benefit, but the local community and its partners will play a leading role in determining if and how OSUWMC will play a role. Local residents serving as Healthcare Extension Agents employed by OSUWMC will be the daily, on the ground presence of ARCH in rural and Appalachian communities cementing our local partnerships and relationships.

Government and Intersecting Private Sector: In addition to local communities, ARCH will establish strong relationships with the Ohio Department of Health Office of Rural Health, the Ohio Rural Health Association, and Ohio University. We will also explore partnerships with other state agencies such as Ohio Department of Agriculture, Ohio Department of Mental Health & Addiction Services, Ohio Department of Veterans Services, the Ohio Department of Aging, Appalachian Regional Commission and Governor's Office on Appalachia may also be interested in collaborating. OSUWMC and other OSU entities have deep ties to these entities, and we intend to build upon those ties with our OSU colleagues.

Private sector groups will help us extend and communicate the vision for and impact of ARCH. This includes the Ohio State Medical Association, the Ohio Hospital Association, and other professional and industry associations such as the Ohio County Commissioners Association, Ohio Association of Community Health Centers, Health Policy Institute of Ohio, the Ohio Business Roundtable, and the Ohio Chamber of Commerce.

ARCH will also establish meaningful engagement with organizations working at the national level to advance the vitality of rural and Appalachian communities, including the federal government and private sector partners such as the National Rural Health Association. ARCH will both learn from and contribute to progress in strengthening rural and Appalachian healthcare.

Finally, OSU has other private sector partnerships with industry that may be interested in contributing to the mission and goals of ARCH. These partners may include telecommunications, information technology, equipment, and other industries that have knowledge, expertise, and solutions to share.

II. Faculty

Criteria for Selecting the Center's Faculty Membership

ARCH will be a center grounded in the principle that partnerships both with faculty and staff on OSU's campuses and community partners will be equal collaborators in advancing opportunities for rural and Appalachian healthcare delivery. Modeled on the OSU College of Food, Agriculture, and Environmental Sciences (CFAES) OSU Extension, ARCH as OSUWMC's Healthcare Extension, will extend relationships and capacity to rural and Appalachian communities in Ohio. Through this collaborative team approach, ARCH and OSU Extension will align our efforts and share resources at the local and state levels to implement healthcare extension programming to empower Ohio communities with knowledge and resources for optimal health and well-being and focus on science-based education and local health care delivery.

ARCH will lead the healthcare extension program across Appalachian and rural Ohio relying on key areas of expertise:

- OSU faculty and staff who are technical experts linked to clinical care innovations/playbooks, translational science/research, education and workforce strategies,
- Regional partners to discover opportunities, co-create and implement solutions to keep care local,
- Healthcare extension educators employed by OSUWMC to advance regional relationships and support program implementation, and
- Extension educators employed by OSU CFAES and experts in the local geography, relationships, and human and community development.

The core team of ARCH includes a mixture of faculty and staff from the OSU health science colleges, CFAES, the College of Education and Human Ecology, and the Wexner Medical Center. We envision that an even broader group of individuals from other colleges and centers across the university will eventually want to participate in the work of ARCH as it grows and matures.

OSU faculty and staff members looking to affiliate with the Center will have a number of options for how to be involved in ARCH's work based on their expertise on Appalachian and rural health topics as well as their current work in these communities. A Membership Committee will be established within the first year to oversee the details of the process for individuals to become a Member of the Center and to promote the benefits of Center membership.

- Membership status – Membership in the center will be reserved for individuals who have a demonstrated, long-term career focus on research, scholarship, teaching, or service to Appalachian or rural areas of Ohio – this could include healthcare delivery, health outcomes, workforce development, economic development, community development, policy, etc. Specific criteria will be developed in the first year of the Center to determine eligibility for membership.

In conjunction with the leadership of the Center, Center Members will be able to participate in helping shape the strategic focus of ARCH through advisory committees or other project-oriented steering committees. If an individual member takes on a formal or leadership role within the Center that requires significant dedicated time, there may be opportunities for those members to receive some funding support from the Center.

- Affiliate status - An affiliate status will be created for individuals with interest in topics related to Appalachian and rural health, but who do not have a specific focus or long-standing commitment to engaging in the work of the Center. In the preceding section, we outline RAIN (Rural and Appalachian Interest Network) as an opportunity to build a network among faculty, staff, and students to support the mission of ARCH. RAIN will play a role in attracting new faculty, staff and learners to the work of the Center leading to them initially to become affiliated with ARCH. Affiliates will be on mailing lists for updates on ARCH's work, will be invited to participate in RAIN events, open conferences, symposiums, volunteer opportunities, etc. The criteria for signing up to be an Affiliate of the Center will be quite open, which will allow many individuals from across the university to learn about the work of the Center and, hopefully, to become more engaged over time to eventually become a Member.

We anticipate the eventual addition of a faculty director with expertise in translational science, policy, and coursework that will advance rural and Appalachian health in Ohio as a complement to the leadership provided by the executive director. An ARCH faculty advisory group will be formed to help envision the faculty aspect of ARCH until the faculty director is onboarded. These advisors will help draft membership criteria, promote faculty recruitment, and contribute to the search process for the new faculty director when the time comes to do so. A strong and selective group of faculty advisors will establish the faculty foundation in collaboration with the leadership of ARCH.

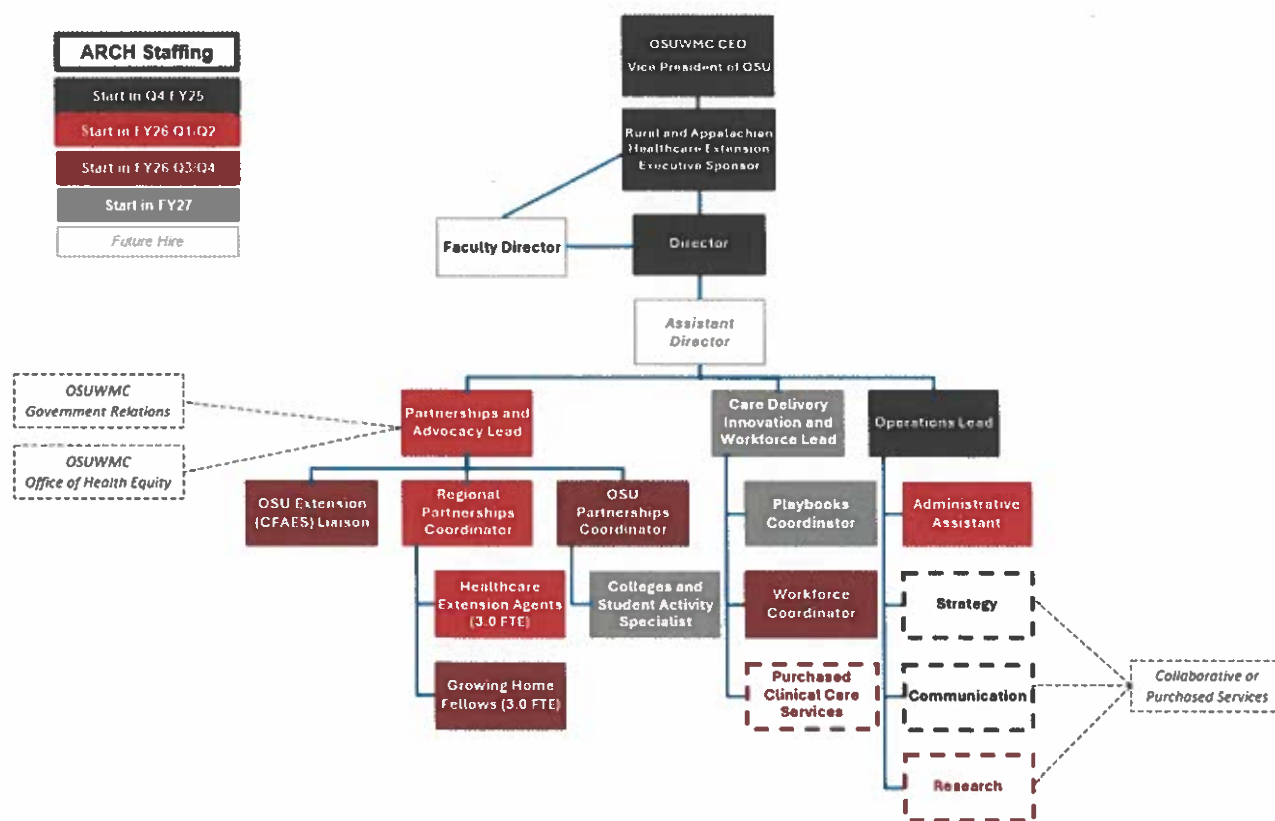
Extent to Which Staff and Students will be Involved

ARCH will be a place for people and organizations interested in extending the capacity of the university to advance research, practice, workforce development, and advocacy with rural and Appalachian Ohio. We envision that staff and learners involved in ARCH will be integral to its sustainability and success.

As noted above, ARCH will establish a Rural and Appalachian Interest Network (RAIN) to engage faculty, staff, and students with personal or professional ties to rural and Appalachian Ohio. The group will provide a platform for networking, idea generation, feedback, and participation in community initiatives. The goal is to foster an environment to share research, educational strategies, volunteer and internship opportunities, and life experiences with an aim of enlarging the number of OSU team members dedicating time and energy to the Center's goals.

III. Administration

The Appalachian and Rural Center for Health is staffed to support partnerships and workstreams in rural and Appalachian regions of Ohio and among OSU's campuses. The organizational chart below depicts the staffing model and timing for positions.



Executive Director and Responsibilities

ARCH is led by an Executive Director, Lori Criss, MSW.

Scope of Position

Under the direction of the Chief Clinical Officer, the Executive Director, Appalachian, and Rural Center for Health (ARCH) provides leadership and support within ARCH for the:

- Development of annual strategic goals and objectives
- Implementation of healthcare extension model
- Expansion of our partnerships with Appalachian and rural healthcare organizations, providers, and communities
- Strengthening our partnerships within OSU with departments, colleges, and regional campuses

- Fiscal management consistent with the annual budget
- Direction of the ARCH team to plan, develop, implement, and oversee initiatives and projects designed to improve healthcare outcomes in Appalachian and rural regions of Ohio.

Position Summary

The Executive Director participates in the development of operational strategy and is accountable for directing operations of the Appalachian and Rural Center for Health. The Director supervises multiple activities including statistical, performance and managerial reporting, budgeting and fiscal management, recruitment and retention of staff, implementation of tactics to forward the strategic plan, and performance improvement initiatives. The Director will manage relationships with internal partners across the Medical Center and university departments, colleges, and regional campuses as well as external partners to facilitate progress toward strategic and operational goals.

Duties and Responsibilities

50% Strategic Direction

- Partner with Medical Center and other university leadership team to establish goals, objectives, and operational plans annually to support the strategic goals of ARCH, the Medical Center, and the university
- Guide the establishment of annual performance metrics/key performance indicators for the ARCH and oversee routine reporting of key metrics.
- Establish and enhance external partnerships with Ohio's Appalachian and rural healthcare organizations, providers, and communities through the healthcare extension model.
- Establish and enhance internal relationships within the Medical Center and university departments, colleges, and regional campuses to align efforts to support ARCH operations and strategic direction.
- Obtain and maintain Center status for ARCH within the university in collaboration with partners in the Office of Academic Affairs
- Actively monitors national trends and issues related to Appalachian and rural healthcare and considers how these trends affect current and future operations.
- Work to develop our statewide and national reputation as a convener and leader in healthcare extension and public policy related to Appalachian and rural health.
- Engage with local, state, and federal government officials, business leaders, and public policy experts on public policy issues related to Appalachian and rural health.

- Cultivate opportunities for external grant and contract funding from governmental entities, foundations, and corporate/private philanthropy.
- Develop and maintain internal and external advisory boards to advise ARCH on strategic direction and effectiveness of operations.

40% Operational Performance & Financial Management

- Establishes both formal and informal internal and external communication structures and processes to ensure effective information sharing.
- Responsible for recruitment and retention of staff, staff engagement, and annual evaluation of all direct reports
- Creates a culture that focuses on customer service, collaboration with external partners, staff participation, motivation, and effective communication.
- Oversee development and implementation of ARCH core functions.
- Utilizes productivity tools to manage resources and support determination of resource allocation.
- Monitors departmental financial performance and propose adjustments to operations if necessary.
- Actively supports the management of the key financial performance indicators.
- Capital and operating budget preparation.

10% other duties assigned by Administrator

Function and Composition of the Oversight Committee

The Oversight Committee will have 50% faculty representation from Columbus and regional campuses on the committee with remaining members representing non-faculty OSU staff, community members, direct care providers, rural health experts, and students. While operational activities and deliverables are the responsibility of ARCH staff, the Oversight Committee will support ARCH in strategic planning and external accountability to its mission and key performance indicators.

Format and Composition

- Meet at least twice yearly
- Initially comprised of staff/faculty from CFAES OSU Extension, College of Education and Human Ecology, and College of Medicine and may evolve over time to include other OSU colleges.
- Representation from multiple OSU campuses will be pursued.
- We will also recruit one undergraduate, one graduate and one professional student.

Functions:

- Support ARCH staff in strategic planning
- Lend subject matter expertise to workstreams
- Make connections with potential partners at OSU and externally
- Provide annual input for continuous quality improvement of ARCH

Reporting Line

ARCH reports directly to the CEO of the OSU Wexner Medical Center and Executive Vice President at The Ohio State University. The Executive Sponsor for ARCH at OSUWMC is the Chief Clinical Officer who reports to the CEO.

Main Components of a Pattern of Administration for ARCH

To ensure that ARCH is effectively and efficiently operating to achieve its mission and uphold the reputation of the university with transparency across key stakeholders, the following are being deployed:

- Accountability: meetings with the CEO of the OSUWMC and Executive Sponsor to review milestone achievement and progress with programmatic and fiscal key performance indicators
- Reporting and communications: newsletter, website, university publications
- Oversight Committee: Meets at least 2x per year
- Partners Meetings and Internal Network Meetings at least 2x per year

IV. Budget/Funding:

Budget for the First Year: \$2,430,586

OSUWMC committed \$2.4 million in FY26 and is projected to commit \$3.2 million in FY27. We are hiring staff in a phased approach across multiple fiscal years to support emerging Center and its initiatives. In FY26, ARCH aims to have 13.25 FTEs and in FY27 that will increase to 18.00 FTEs. Concurrently, we will explore and engage faculty across OSU to advance the goals of ARCH and in alignment with their teaching, research, and service agendas. This may include the buy-down of time from some key faculty to be directly involved in implementing ARCH initiatives.

Funding Sources and Sustainability

Initially, OSUWMC will fund this rural and Appalachian initiative prioritized in Impact 2035 strategic plan. Based on the experience of similar institutions at other universities, we predict the ability over time to bring in philanthropic and grant funding to help support the core functions of the ARCH. Securing philanthropic champions and creating a process for finding, pursuing, and securing grant funding for the university and local partners is a priority. ARCH will seek extramural funding from local, state, and federal public and private sources to augment the institutional support. Some permanent level of OSUWMC operating investment is expected.

Equipment, Space, Facilities Needed to Fulfill the Center

The OSUWMC is providing equipment and space for ARCH. No new facilities are needed.

V. Evaluative Criteria and Benchmarks

Supporting healthcare providers and their partners in addressing challenging health behaviors and outcomes in rural and Appalachian Ohio is crucial for improving the well-being Ohioans and the state. Setting clear and measurable indicators will help us understand the impact of our efforts, ensure that we are making meaningful strides towards better health outcomes for the rural and Appalachian populations, deploy continuous quality improvement with our partners, and create data for advocacy and use by public policy makers.

The vision and mission for the ARCH positions the team at OSU to advance relationships, deepen partnerships, extend capacity to improve health outcomes in partner communities and eventually scale solutions regionally or statewide. Achieving this will take time. In the first two fiscal years, becoming efficient with the phases of work: Partner, Discover, Co-Design, Deliver, and Disseminate will be the priority. This will set us up for rapid and efficient expansion and scaling of the healthcare extension model in future years.

A comprehensive evaluation plan for ARCH will be developed this fall. Benchmarks for FY26 include the following.

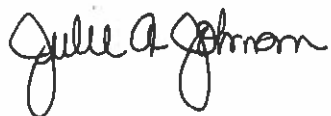

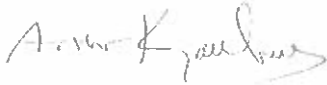

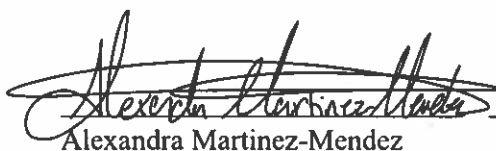
