

Dear Randy:

The Arts and Sciences Committee on Curriculum and Instruction (CCI) unanimously approved a revision to the **Folklore Minor** on April 9, 2010. Due to the modest nature of the revisions, this proposal was expedited by the Chair of CCI, Rebecca Harvey, the Vice-Chair of CCI, Terry Gustafson, and the Associate Dean for Curriculum in Arts and Humanities, Valarie Williams.

The proposed minor remains at 24 credit hours. A significant number of courses have been added to the minor and it was, therefore, brought to CCI as a revision. The departments involved in the minor determined which courses they wished to add and the additions were approved by the Comparative Studies Department, which administers the minor. Also, several courses were removed from the minor which are no longer offered.

Finally, some additional clarifications were added for students regarding pre-requisites and the number of 200-level courses students are allowed to take under ASC Minor Guidelines. The rule states that "at least half of the hours [must be] at the upper-division level (300 level or above, Philosophy 250, all courses taught by the College of Mathematical and Physical Sciences at the 200 level, and foreign language courses taught in the language at the 200 level)." All of the courses at the 200 level in this minor are taught in English.

The CCI determined these changes to be appropriate and increased choice and clarity for students interested in the minor.

Please let me know if I can be of further assistance as CAA considers this proposal.
