RE: Categories and Expansion of Academic and Other Certificate Programs

Academic and other certificate programs as standalone, non-degree program offerings have become increasingly common at universities throughout the country. During recent years, as these programs continued to emerge elsewhere, the question regarding certificate programs, especially those offered for academic credit as standalone programs, has been discussed within several units and at several levels at The Ohio State University (OSU). It was known that the OSU Graduate School offered a few academic certificate programs, but these were not standalone programs and instead were only permissible if students were concurrently pursuing a graduate degree.

A discussion at the Academic Program Advisory Committee (APAC) led to an informal exploration of what currently is being offered. It was determined that several academic credit and non-credit programs and courses are offered as "certificates", "certificates of completion", and "certifications" by several units within the University. It was determined by APAC that there was a need for increased clarity regarding the types and the differences among these programs and courses offered.

Accordingly, I convened a subcommittee, led by Michael Bisesi, College of Public Health, consisting primarily of APAC members, to discuss and establish categories and criteria to inventory and organize existing programs and courses and develop new ones that lead to certificates, certificates of completion and certifications. The attached table defines and differentiates between the types of these programs and courses offered for credit and noncredit.

This document will need to be reviewed, and approved by the Council on Academic Affairs, and that Council will need to specify the approval process for those that are credit-bearing. The Office of Academic Affairs will need to determine the process for documenting those that are <u>not</u> credit bearing.

After your review, I would like this placed on the agenda of a forthcoming Academic Affairs leadership meeting.

Academic Certificate programs refer to those that require completion of courses with academic credits. Academic certificate programs are "stand-alone" or "independent" programs, which mean they do not need to be completed as part of an academic degree program. This is the primary distinction when compared to minor programs or specialization tracks which only can be completed coinciding with an academic degree.
