RE: Revised Master of Architecture Curriculum Change Proposal

The Architecture section is proposing changes to the Master of Architecture curriculum effective AU20. The M. Arch program at the Knowlton School is grounded in an understanding of architecture as both a design profession and a cultural discipline. While the current curriculum is designed with this in mind, the changes proposed here will provide a firmer grounding in architectural culture for students entering the program in the first year and ensure a clear understanding of architecture's cultural obligations for students entering with advanced placement.

The combined Graduate School/CAA curriculum subcommittee requested that we describe how these changes will be assessed relative to our current learning outcomes. This can be found on page 7.

I. Introduction and Rationale for the Changes

The M. Arch program at the Knowlton School is grounded in an understanding of architecture as both a design profession (i.e., a service to society) and a cultural discipline (i.e., an art form). The curriculum changes outlined below will better align our course sequence with this dual agenda, providing a solid grounding in architectural culture for students entering the program in the first year (G1), by moving ARCH 7210 to first year, and ensuring a clear understanding of architecture's cultural obligations for students entering with advanced placement (G2), with the introduction of ARCH 5130. These proposed program changes came out of a review of the Master of Architecture curriculum which was conducted during the 2018-19 academic year.

Summary of changes:

- a. ARCH 7210 (6210)
 - We are moving ARCH 7210 from the 2nd year to the 1st year of the program's curriculum.
 - o We are changing the course number to 6210 to align with other 1st year courses.
 - Students in the 3 year program will simply take ARCH 6210 in the 1st year and move ARCH 5710 to the 2nd year.
 - Students who enter the program with advanced placement and begin in the 2nd year of the program will no longer be required to complete this course. Instead of taking ARCH 6210 which is 3 credit hours, students with Advanced Placement will take 3 credit hours of electives.
 - The total credit hours for the degree will remain at 96 for students in the 3 year program and 63 for students in the 2 year program.
- b. ARCH 5130 and ARCH 5210
 - o ARCH 5130 is a new course that will become a required course.
 - ARCH 5210 will be removed from the curriculum, and ARCH 5130 will take the place of ARCH 5210.

Every effort will be made to do no harm to students during this transition. Because our program is very prescribed and cohort-based, we are confident that the transition will be seamless for students in each year of the program. The attached transition curriculum guide outlines how students will move through the program according to which year(s) they have completed prior to the implementation of the changes.

For the 2019-20 academic year, we have adjusted our class schedule to reflect the changes for when students will complete specific courses. Students in the G2 year in 2019-20 are encouraged to take ARCH 5130 instead of ARCH 5210 and replace ARCH 7210 with 3 credit hours of electives.

ASSESSMENT OF THE PROPOSED CHANGES TO THE CURRICULUM

The proposed curricular changes are directly associated with our Cultural Context outcome. As a professional program the primary goal of the curriculum is to situate the disciplinary role of the architect within culture and to prepare future architects for the demands of operating in a complex global society. A direct way of assessing this outcome is through the Master Project, the M. Arch program's master examination where students are required to ground their design work within a broader cultural context. The Master Project is developed and produced in two sequential courses: ARCH 8220 and 8420*. The content and structure of ARCH 8220 (where foundational research is undertaken) is generally assessed monthly by the Architecture Graduate Curriculum Committee. The culminating work of ARCH 8420 (the Master Project) is reviewed by three constituencies: a subset of the Graduate Curriculum Committee, invited Knowlton Faculty, and significant architects outside of the School. The discussion of these constituencies, along with the success or failure rate of the projects (as determined by vote of the students' committees) serves as a measure of this desired outcome**. The spring faculty retreat provides a venue for synthetic discussion and the proposal of any changes for the following year which will continue to be vetted through the Architecture Graduate Curriculum Committee.
