# Proposal to Revise the Psychiatric Mental Health (PMH) Nurse Practitioner Specialty Track Curriculum in the M.S. in Nursing Program College of Nursing October 2019

#### Introduction and Rationale

This proposal requests minor revisions of the Psychiatric Mental Health (PMH) specialty track curriculum in the M.S. in Nursing program. Two changes are proposed as follows to enhance the quality of the PMH specialty track curriculum:

- Replacement of the currently-required didactic portion of the Nursing 7338.01 course with the existing Nursing 7331 course.
- Credit-neutral redistribution of the didactic and clinical credits for the clinical practicum course series (Nursing 7348.01, 7348.02, 7348.03.

Nursing 7338.01 focuses on the general health promotion and preventive care for pediatric populations in primary care settings. The rationale for replacing the didactic portion of Nursing 7338.01 (Advanced Nursing Practice in Pediatric Primary Care I) with Nursing 7331 (Assessment and Management of Child & Adolescent Mental Health Issues) is to improve educational content in the PMH specialty track curriculum as consistent with contemporary national standards and population nursing care needs across the lifespan.

The didactic portion of Nursing 7338.01 was originally introduced in the curriculum to provide advanced child development content for PMH specialty track students. However, it has recently been identified that Nursing 7331 can provide enhanced advanced content concerning growth and development as applied to the behavioral and mental health needs of children and adolescents. Also, skills-building activities in Nursing 7331 provide improved advanced training in screening for developmental and behavioral disorders in children and adolescents. In addition, PMH specialty track students enrolled in the Graduate Entry option of the M.S. in Nursing program currently do not take coursework focusing on advanced child development topics that are addressed in Nursing 7331. Replacement of Nursing 7338.01 with Nursing 7331 will assure that all PMH students will have the same advanced curriculum content on assessment and management of child and adolescent mental health issues.

All students who are currently enrolled will be able to complete their programs of study with the same total number of credits. The proposed replacement of Nursing 7338.01 with Nursing 7331 is credit-netural for traditional M.S. in Nursing and BSN-DNP students in the PMH specialty track. There will be a net increase of 3 program credits for the Graduate Entry option students beginning with the cohort that will matriculate in Summer 2020 and who will be required to take Nursing 7331 by Summer 2022. The proposed credit-neutral redistribution of the clinical practicum course credits for Nursing 7348.01/7348.02/7348.03 better optimizes the credit load balance across semesters for students who are enrolled in the specialty track curriculum.

The curriculum transition plans for the proposed curriculum changes are summarized in the attached tables on p. 2. The revised syllabi for Nursing 7348.01/7348.02/7348.03 are attached on pp. 3 – 5. The syllabus for Nursing 7331 is attached on p. 6.

### Assessment and Management of Child and Adolescent Mental Health Issues Nursing 7331 3 Credits (didactic)

#### **Prerequisites**

Enrollment in M.S. in Nursing program, prior successful completion of an advanced health assessment course, and concurrent enrollment in an advanced pediatric acute or primary care clinical practicum course (Nursing 7218.01, Nursing 7218.02, Nursing 7338.01, or Nursing 7338,02), or permission of instructor.

#### **Course Description**

Application of theories, research findings, assessment, and clinical management principles to evidence-based child and adolescent mental health screening, early intervention, and mental health promotion.

The AACN Essentials of Masters Education in Nursing (2011), the Criteria for Evaluation of Nurse Practitioner Programs (NTF, 2012), and the Pediatric Nursing Certification Board Program Criteria for PNP Programs (2008) were used to guide course development.

#### **Course Objectives**

- 1. Describe the epidemiology of child and adolescent mental health disorders.
- 2. Discuss key screening tools, clinical interview questions, and principles of assessment of children and adolescents for mental health issues.
- 3. Analyze evidence-based and culturally appropriate mental health promotion and risk reduction interventions for children, adolescents, and their families.
- 4. Discuss evidence-based clinical assessment and intervention principles for children and adolescents who have mental health disorders, including when to make a referral to psychiatric specialty care.
- 5. Analyze considerations of collaborative care and engagement in community agency partnerships to achieve accessible, high quality mental health care.
- 6. Apply mental health assessment principles to conducting and documenting a comprehensive mental health assessment interview with a child or an adolescent in a selected concurrently-taken pediatric clinical practicum course.

#### **Content Topics**

- Epidemiology of child and adolescent mental health disorders
- Mental health disorders in children and adolescents: depressive, autism, attention deficit, somatic, bipolar, anxiety, trauma and stressor-related, disruptive behaviors, feeding and eating, and substance use disorders
- Mental health screening and assessment
- Evidence-based mental health treatment (pharmacological and non-pharmacological) and mental health promotion and risk reduction interventions
- Ethical, legal, and professional issues related to child and adolescent mental health care
