Please find a proposal to revise the Master of Arts in Teaching and Learning with a specialization in Teaching English to Speakers of Other Languages

The College of Education and Human Ecology is proposing to revise the Master of Arts in Teaching and Learning with a specialization in Teaching English to Speakers of Other Languages. The proposal will rename the "Foreign, Second, and multilingual language education (fsmle) to "Teaching English to speakers of other languages (TESOL)" and reduce the number of required credits. Specifically,

- Reduce the number of required credits from 18 to 9 by moving 2 courses to the elective course list
- Expand the offerings in the elective course list
- Replace edutl 7645 with edutl 5645
- Change the names of three courses to reflect contemporary theory, research and pedagogy
- Delete 2 courses

Dear Curriculum Committee Members,

The faculty in Multilingual Language Education in the Department of Teaching and Learning submit additional comments about the Master of Arts in Teaching and Learning with a specialization in Teaching English to Speakers of Other Languages (TESOL), answering questions raised by the combined Graduate School and Council on Academic Affairs (GS/CAA) meetings held in January 2023.

1. The % change in credit hours: There will be no change in credit hours.

2. Transition plan for current students

Students starting the program in Autumn 2023 will be admitted to the new plan. A new sequence of course offerings will be implemented starting in the autumn semester. Students who start in Summer 2023 or earlier will be able to complete the MA degree program on their current Program of Study by substituting a course with the equivalent previous course (e.g., EDUTL 5600, Language as a Resource, can be substituted for EDUTL 5630). Students who elect to move to the new Program of Study may substitute any prior courses for the new ones.

3. Anticipated impacts on current students

There are relatively a small number (<10) of students currently admitted to the MA in Teaching and Learning with a specialization in TESOL. They will not be adversely affected, as all students will be able to stay on their current program sheet or move to the new sheet as explained in # 2 above.

4. Impact on the assessment plan for the program

We do not expect much impact on the assessment plan for the program because the major proposed change is to change 18 credits of requirement in Area of Study (TESOL) into the combination of 9 credits of requirement and 9 credits of electives in Area of Study. As can be seen in the Table below, there will be little changes in terms of courses that will be offered. The three required courses (EDUTL 5615, 5620, 5645: yellow highlights) will continue to be required, and some of the previously required courses (highlighted in green) will be moved to the elective course list. We expect to strengthen the program by providing students with more elective options.

The faculty in Multilingual Language Education (MLE) in the Department of Teaching and Learning submit the Program Changes to the **Teaching English to Speakers of Other Languages (TESOL)** specialization in the Masters in Teaching and Learning (MA) outlined below for your review. The proposed changes will reconfigure the TESOL MA Program by decreasing area of study required credits and increasing area of study elective course options. The proposed changes are intended to allow students more flexibility in how they complete the program.

Note: This proposal includes the current EDUTL prefix for courses. Depending on the timing, the new department prefix(es) could be used to update the study plan.

1. Change the name of the program from Foreign, Second, and Multilingual Language Education (FSMLE) to Teaching English to Speakers of Other Languages (TESOL)

The proposed change will change the name of the program from Foreign, Second, and Multilingual Language Education (FSMLE) to Teaching English to Speakers of Other Languages (TESOL).

<u>Rationale</u>: TESOL is the most recognized name in the field, and many peer programs are titled MA-TESOL. The name change will give the program more visibility, especially for international students, and help recruiting efforts.

2. Reduce the number of aera of study required credits to 9 credits and move some required courses to electives

The MA program currently requires 18 credits (6 courses) of area of study courses. The proposed plan of studies would reduce this to 9 (3 courses) and move some of the required courses to electives. The following courses will be removed from a required course list and moved to an elective course list:

- EDUTL 5610 Literacy Development for Multilingual Learners (previous title: Language Arts & ESL Instruction (3)
- EDUTL 5640 Instructional planning and advocacy for multilingual learners (previous title: Syllabus & Materials Development in Second Language Teaching (3)

Rationale: In order to complete the program, students are required to take a minimum of 31 credits, including 18 area of study credits. Currently, students are required to take 18 area of study required credits (6 courses), which leave students have no room to take any elective courses. The reduction of required credits (from 18 to 9 credits) will provide our students with more opportunities to take various elective courses of their interest. The new plan will have 9 credits of required area of study coursework and 9 elective credits.

3. Add more area of study elective courses.

The proposed plan of studies would add more area of study elective courses. As noted above, two area of study required course (5610, 5640) will be moved to electives and add more elective courses that already exist in the closely related program in TESOL and World Language Education. The following courses will be listed in an elective course list:

- EDUTL 5610 Literacy Development for Multilingual Learners (previous title: Language Arts & ESL Instruction (3)
- EUDTL 5640 Instructional Planning and Advocacy for Multilingual Learners (previous title: Syllabus & Materials Development in Second Language Teaching (3)
- EDUTL 5365 Linguistics for Literacy Educators (3)
- EDUTL 5600 Language as a Resource (3)
- EDUTL 5612 Secondary Methods in World Language Education (3)
- EDUTL 5613 Core Practices in World Language Education (3)
- EDUTL 7625 Technology in language learning and teaching (3)
- EDUTL 7189 Field experience (3)

<u>Rationale:</u> A proposed change will allow students to have more flexibility with electives. This maximizes the options for them to find courses that appeal to them and fit their schedule.

4. Replace EDUTL 7645 with EDUTL 5645

EDUTL 7645, Issues & Research in Foreign Language Testing and Assessment (3) is one of area of study required courses that addresses issues in *language assessment*. Recently, the instructor of 7645, Dr. Francis Troyan, newly developed a course, EDUTL 5645: Core Practices in Language Assessment to replace 7645. Thus, the proposed plan would replace 7645 with 5645.

<u>Rationale</u>: EDUTL 5645 was recently developed to allow for the consolidation of language assessment courses across a variety of programs. This proposed change will make the program more sustainable in terms of enrollments by taking advantage of the areas of alignment with coursework that already exists in the closely related program in TESOL and World Language Education.

5. Name change for three courses (5610, 5620, 5640)
