#### Rationale

We are making adjustments to the Glenn College Nonprofit Management minor as part of a restructuring of the way Glenn College students specialize their studies. Presently, the Glenn College offers specialization tracks as part of our Bachelor of Arts and Bachelor of Sciences programs. We are transitioning our internal specialization tracks to minors to streamline programming. We currently offer five minors and six specializations, resulting in 11 subprograms. Ultimately, by transitioning our specializations to minors, we will reduce our offering to eight minors (no specializations). During this process, we are making a small change to our existing Civic Engagement minor to add our new class, Public Affairs 5120: Social Change Advocacy: Organization, Mobilization, and Activism, to the options for the core requirements. This class was developed after the creation of the minor, but we feel that its content is very relevant to the learning objectives of the minor, and should therefore be included as an option for students. Through this and other changes to our other minors, we aim to simplify our offerings for both students and advisors and expand access to our programs for students across campus.
