#### Rationale

We are making adjustments to the Glenn College Nonprofit Management minor as part of a restructuring of the way Glenn College students specialize their studies. Presently, the Glenn College offers specialization tracks as part of our Bachelor of Arts and Bachelor of Sciences programs. We are transitioning our internal specialization tracks to minors to streamline programming. We currently offer five minors and six specializations, resulting in 11 subprograms. Ultimately, by transitioning our specializations to minors, we will reduce our offering to eight minors (no specializations). During this process, we would like to redesign the Nonprofit minor to make it accessible to our students and take advantage of many of the new course offerings from the Glenn College other colleges that has become available since the initial development of the Nonprofit Management minor. Additionally, we are removing courses that are not as relevant to the learning outcomes of the minor or that have not been offered with regularity over the last 3 years. Finally, we have divided the list of electives into three subcategories, each focusing on a different area related to successfully administering a nonprofit organization. We hope that his new organization of the minor's elective courses will be helpful to students as they map out degree plans. Through this and other changes to our minors, we aim to simplify our offerings for both students and advisors and expand access to our programs for students across campus.
