Dear Randy:

I am writing to inform you that the John Glenn College of Public Affairs supports the structural and application timeline changes to the BA/MPA and BS/MPA programs approved by the College's graduate and undergraduate curriculum committees in November of 2023.

The changes are in response to the Ohio Department of Higher Education's decision to limit the number of credit hours that can overlap between a bachelor's and master's degree as part of a combined program. The Glenn College revised our combined degree programs to adhere to this new policy and attached you will find curriculum guides reflecting the changes. Additionally, we have included a matrix document that lists the different options for Glenn College undergraduate students who are interested in pursuing our MPA. This document will also be shared with students as an advising tool to help them inform their decisions.

Current students in the combined 3+2 program are not impacted by these changes and they will continue to follow their current degree plan. The changes will be implemented for students beginning the combined degree program in autumn semester 2024 by taking graduate classes via senior petition and officially starting the MPA program in Spring 2025.

# Proposal to Update the Combined BA/MPA and BS/MPA Program

# **Proposal Overview**

The combined BA/MPA and BS/MPA programs allow students to complete an undergraduate and graduate degree from the John Glenn College of Public Affairs in less time than it would take to earn both of them individually. The programs were designed to be completed in 5 years, but students have been able to complete them in 4 years if they enter Ohio State with more credit earned through dual enrollment and/or test scores. Since the program's launch in 2018, eleven students have completed it, graduating with both degrees. Currently 15 students are enrolled.

In response to new policies from the Ohio Department of Higher Education limiting the number of combined credit hours that can be completed by students, the Glenn College has revised the application timeline for students interested in the combined programs.

# **Proposed Changes**

#### 1. Reduce the number of combined hours

In order to comply with the new regulations from the Ohio Department of Higher Education, the Glenn College is reducing the number of credit hours that students can use as combined credit for the undergraduate and master's degree programs from 18 to 9.

#### 2. Increase the use of credit via senior petition

In order to account for the change in combined credit hours, students in these programs will take an additional 9 hours of graduate credit through the senior petition process. They will complete these credits during fall semester of their fourth year and start the MPA the following spring.

#### 3. Change the application timeline for the combined programs

To ensure that students make proper use of the senior petition and combined credit hours, we propose altering the application timeline for the program. Under this new model, students interested in the program will apply for the MPA by March 1 of their third year of undergraduate studies. Prospective combined students will apply for a spring MPA start term, rather than a traditional autumn start. This will allow them to complete 9 hours of graduate credit via senior petition during the fall of their fourth year. Admitted students will then begin the MPA program the following spring semester. Both undergraduate and graduate stacks will remain open in SIS during this spring term. Upon the conclusion of the fourth year, students will graduate with their undergraduate degree and the undergraduate stack will close. Students will proceed to their fifth year as traditional MPA students and will graduate accordingly. For students who enter Ohio State with significant prior credit and wish to complete the combined program in four years, the above timeline will be moved up by a year. These students will apply for the MPA by March 1 of their second year, take 9 hours of graduate credit via the senior petition in fall semester of their third year, begin the combined program in spring semester of their third year, graduate with their undergraduate degree after that semester, and graduate with their MPA degree upon the conclusion of their fourth year.
