Dear Dr. Weaver,

The Health Information Management and Systems (HIMS) division has an online standalone certificate named Medical Coding and Health Care Data Analytics for Practice. It is designed to provide in-depth education on medical code data sets, data capture, revenue cycle management, reimbursement, technology tools and how to analyze health care information.

Based on keyword research by the Digital Learning Team, it was suggested we revise the name of the certificate and remove the word "coding." This was recommended because the current program on the HRS website is ranking for "medical coding" terms on search engines, and the certificate is not designed to teach the skills to become a credentialed medical record coding specialist.

The HIMS faculty recommends changing the certificate's name to the Health Care Revenue Cycle and Data Analytics Certificate. This name better reflects the content of the program as the first 2 courses cover medical coded data and the health care revenue cycle, and the last 2 courses cover health care data analysis.

In researching comparable certificate programs, our certificate differentiates itself by teaching students about medical coding and health care data analytics. The Healthcare Financial Management Association offers the CRCR (Certified Revenue Cycle Representative) certificate, the University of Cincinnati offers a Revenue Cycle Management certificate online, and the Medical Group Management Association offers a Revenue Cycle Management certificate. None of these appear to include data analytics. Marshall University offers a Data Analytics in Health Care Certificate, and The University of Texas Rio Grande Valley offers the Healthcare Analytics Certificate Online Program. These programs do not appear to include medical coding.

I am requesting approval of this name change by the Curriculum Committee.
