Dear Dr. Smith

Attached please find a minor revision to the Agricultural Communication major offered in the Department of Agricultural Communication, Education, and Leadership in the College of Food, Agricultural, and Environmental Sciences. After review of the curriculum and the student experience for this major following the implementation of the new General Education Curriculum, it became apparent to the faculty that the requirement for a second internship experience (beyond the experience required for the BSAGR) was causing issues for students in the post-COVID environment, and was not required for students to gain the skills needed to be successful. While some students continue to benefit from a second internship experience, others can gain quality experiences through other course options. Therefore, the faculty determined it was in the students' best interest to move the second internship requirement (AGRCOMM 4191.02, Advanced Agricultural Communication Internship) from a major requirement into the list of major elective options, thereby decreasing the required course credits by 3 credits (from 44 to 41) and increasing the elective course credits by 3 (from 6 to 9), with no impact on overall credit hours required to complete the major. This adjustment will not have an impact on current students, and the option has already been implemented for some current students by petition.

Attached you will find a cover letter from Dr. Emily Buck who oversees this major as well as the current, current with changes identified and updated curriculum sheets. This update has been approved by the Department of Agricultural Communication, Education, and Leadership in the College of Food, Agricultural, and Environmental Sciences as well as Dr. David Barker and Dr. Monica Lewandowski, current and incoming Chairs of the CFAES Committee on Academic Affairs (COAA). It will be shared with the CFAES COAA as an information item at a future meeting. I believe this can be shared as an information item with the Council on Academic Affairs – if you believe this will require a vote for approval (rather than shared as an information item), please let me know and I will prepare a formal proposal for revision.

Please accept this letter as a request to update the requirements for the agricultural communication major in the Department of Ag Communication, Education, and Leadership. As the faculty has assessed the major post the new GE requirements being in place, we have found the need to reduce the amount of internships required of our students.

We are requesting that the second internship requirement, that is a course above the college's requirement, be moved to the elective basket of the major and the amount of major elective hours be raised from 6 to 9. We feel students who still want to do a second internship for credit would still be able to and could count it in their electives. However, it would not continue to hinder students who are struggling to find a second internship in this work environment. After thorough analysis we feel students could gain skills in another major elective equivalent to that that they may gain in this second internship.

We are committed to ensuring that this change will not impact any students currently in the major as they will continue on in their current plans. If a current student wishes to follow this new curriculum, which will go into place no sooner than Fall 2025, we will work with them on a one-on-one basis following college procedures.



- Students must complete a minimum of 40 hours in major/major supporting coursework with at least 12 hours taken from the academic unit(s) offering the major at OSU in the baccalaureate program.
- Courses required in the major (including major supporting courses and major electives) may not be taken pass/non-pass.
- Coursework taken as open electives may include a maximum of 4 credit hours of physical activity courses (all 1139-1197 courses), and a maximum of 4 credit hours of campus music organizations.
- A college maximum of six hours of individual studies courses (x193) can be applied toward graduation; some majors may have a lower maximum.
- Students of CFAES must complete an internship of 1-2 hours as a requirement for degree. Any additional internship credit hours may count towards major hours (consult with your advisor). A college maximum of six hours of internship credit can be applied toward graduation; some majors may have a lower maximum.
- A maximum of three credits of 3488 can be applied toward graduation although some majors may have a lower maximum. A cumulative point-hour ratio of 2.0 is required to register for 3488 credit.
- Credit hours for 4999 ("with Research Distinction") and 4999H ("with Honors Research Distinction") are repeatable to maximum of six hours
- An application for degree must be submitted online at least two semesters prior to the intended graduation term. Application found at: https://students.cfaes.ohio-state.edu/academics/undergraduate/graduation

- Policies and General Requirements for Minors/Minor Equivalent
 The minor/minor equivalent must contain a minimum of 12 credit hours distinct from the major and/or additional minors (i.e., if a minor requires more than 12 credit hours, a student is permitted to overlap those hours beyond 12 with the major or with another minor).
- A 2.00 cumulative point-hour ratio is required in the minor/minor equivalent with a minimum C- grade for any course to be listed in the minor or minor equivalent (includes transfer credit).
- For programs requiring a minor: minors should be declared by the time students complete 60 hours.
- A student is permitted to count up to 6 credit-hours of transfer and/or EM credit in the minor or minor equivalent
- Coursework graded Pass/Non-Pass cannot count in the minor. No more than 3 credit-hours of course work graded S/U may count toward the minor. Maximum of 3 credit-hours of xx93 are allowed to count in the minor.
