

Stackable Certificates

- Proposals being submitted to GS/CAA
- Implementation document subcommittee
- Approval processes and technical workflow -- GSCC
 - Student Beginning in a Degree Program and Adding a Certificate enroute
 - o Student Beginning in Both Degree and Certificate Program
 - Student Beginning in a Certificate only and Entering a Degree
 - Graduate Non-Degree
- One MOU, one proposal for all components—explaining plan
- <u>https://go.osu.edu/stackablerecommendations</u> (draft)
- Graduate Council seeking feedback from pilot

Where things stand

Micro-credentials

- FCOB proposals submitted (Leadership Initiative and FinTech)
- Confusion around CAA process—Alternative Credentials framework not leveraged
- Confusion between non-credit and non-degree
- Confusion between participation and assessed skill/competency
- Confusion between certification and certificate
