Dear Chair and Members of the Arts and Sciences Curriculum Committee:

On September 11, 2024, the Arts and Humanities Subcommittee 2 reviewed a request from the Department of Theater, Film, and Media Arts to revise the minor in Screenwriting by i) adding one existing course (FMST 4890: Advanced Screenwriting) and 2) streamlining/simplifying the requirements for the "Screenwriting Concentration" category.

The minor requires 15 credit-hours split up in the following fashion:

- Intro to Film Studies (3 ch) -select 1 of 5 course options
- Intro to Storytelling (3 ch) select 1 of 8 course options
- Screenwriting Concentration (9 ch)
 - CURRENT requirements: Students must take a course in each of 3 sub-categories (Intro to Development, Intro to Screenwriting, the Business of Screenwriting) that each offer only 1-2 course options
 - PROPOSED requirements: Eliminate the subcategories and have students to select 3 courses from among 5 course options (FMST 4890 will be added to this part of the minor)

The changes have the following advantages: a) providing greater flexibility to students; b) spreading enrollments across screenwriting courses; and c) eliminating over-enrollment/waitlisting in specific screenwriting courses. The proposed changes will not change overall required credit hours or change existing prerequisites for existing courses.

A&H Subcommittee 2 voted unanimously to approve the request with no contingencies. The proposal is now advanced to the ASCC with a motion to approve.

To the Council on Academic Affairs,

The Department of Theatre, Film, and Media Arts wishes to advance a proposal to add one existing department course to the Screenwriting Minor (FILMSTD 4890 "Advanced Screenwriting") to count toward the Minor in Screenwriting.

We additionally would like to make a minor curriculum adjustment to the Screenwriting Minor and remove a set of subcategory divisions under the "Screenwriting Concentration" course list within the minor. The minor is currently divided into three units: "Intro to Film Studies," "Intro to Storytelling," and "Screenwriting Concentration," each with a list of course options. The Screenwriting Concentration unit is then further subdivided into three subcategories that limits course selection by enrolled students as part of a prescribed sequence. The department advocates removing the subcategories, so as to allow more flexibility of course selection in the minor. The course list and requirements of the minor would otherwise not be changed, but students would be able to select three of five courses in the Screenwriting area (respecting existing course prerequisites).

The department supports these requested changes which will potentially bolster enrollments in FILMSTD 4880 and 4881 "Business of Screenwriting" sections and will increase availability of screenwriting seats for students who wish to take our in-demand courses of FILMSTD 4800 "Story Development" and THEATRE 5331 "Screenwriting introduction," both of which are frequently over-enrolled and waitlisted.

All five of our screenwriting courses are led by an instructional team who can provide the same broad training across the course catalogue. The removal of the subcategory divisions for the course list in the Screenwriting Concentration credit hours will allow students to select three of five available courses, respecting current course prerequisites, but removing barriers to enrollment. These changes do not remove any other existing credit hour or course requirements in the minor but simply redirect enrollments to more of the courses already approved for use in the minor. I support these proposed changes.

THEATRE, FILM, AND MEDIA ARTS - Course addition and amendment to Screenwriting minor

Administered by the Department of Theatre, Film, and Media Arts, the Screenwriting Minor combines theory and practice to prepare students to develop original stories, scripts, and screenplays for production as works of movingimage art. The Screenwriting minor integrates creative practice with critical study. In addition to developing skills for writing for the screen in a variety of forms, students garner a foundational understanding of film history and theory and of storytelling conventions across media. In the minor, students hone their distinct voice, and gain crucial professional experience for careers in film and television writing.

Students are required to complete 15 credit hours to complete a Screenwriting Minor.

Current requirements – see advising guide for full requirements of minor:

- I. Introduction to Film Studies (3 credit hours): Students select one of five course options.
- II. Introduction to Storytelling (3 credit hours): Students select one of eight course options.
- III. Screenwriting Concentration (9 credit hours): Students must complete nine credit hours split across three different screenwriting subcategories:
 - 1. Introduction to Development Course (3 CH)
 - Students must take FILMSTD 4800
 - 2. Introduction to Screenwriting Course (3 CH)
 - Students must take THEATRE 5331
 - 3. Business of Screenwriting Course (3 CH)
 - o Students must take either FILMSTD 4880 or 4881

1. Proposed addition of existing TFMA course FILMSTD 4890 "Advanced Screenwriting" to extend possible course options in Screenwriting Concentration. FILMSTD 4890 is an intensive screen/script writing course taught by Screenwriting (TFMA/ENGLISH) faculty member, Angus Fletcher. This course is currently not part of the Screenwriting minor but is offered once every year and is a popular course that minors often take as a supplement to their learning (but it does not currently contribute to their current minor course requirements).

2. Removal of the Subcategories under "Screenwriting Concentration" area of minor requirements

The Screenwriting Concentration is currently divided into three subcategories. Nine required credit hours are currently divided between three subcategory areas, "Development," "Introduction to Screenwriting," and "Business of Screenwriting" subcategories. We propose condensing the course lists of these three subcategories into one list of five options under "Screenwriting Concentration," and removing the subcategory requirements.

Students will still be required to complete 15 credit hours to complete a Screenwriting Minor.

Proposed requirements – see advising guide for full requirements of minor:

- I. Introduction to Film Studies (3 credit hours): Students select one of five course options.
- II. Introduction to Storytelling (3 credit hours): Students select one of eight course options.

 Screenwriting Concentration (9 credit hours):Students select from five course options.

 Students may select three of the five courses below:
 - FILMSTD 4800 (already part of minor in this Screenwriting concentration area)
 - FILMSTD 4880 (already part of minor in this Screenwriting concentration area)
 - FILMSTD 4881 (already part of minor in this Screenwriting concentration area)
 - FILMSTD 4890 (existing course, new addition to minor; see #1)
 - THEATRE 5331 (already part of minor in this Screenwriting concentration area)

Justification: The change would allow students more freedom to select from available course options already part of the minor. The removal of subcategories under "Screenwriting Concentration" would not change credit hours, minor requirements, or the course list of available options; the restructure simply reduces barriers to enrollment and minor completion by allowing course selection to be modular, rather than sequenced.

Removal of the subcategories under "Screenwriting Concentration" still respects the flow of THEATRE 5331/ FILMSTD 4800 as introductory screenwriting courses in the major due to the existing prerequisites for courses, but the removal of the subcategories in favor of a course list would eliminate artificial sequencing that restricts course selection.

Benefits of proposed changes:

- Change will reduce obstacles students face when enrolling for courses in the Department of Theatre, Film, and Media Arts. The Screenwriting Minor has grown in number over the last several years, and Academic Advising/the department has had to entertain several course petition requests from graduating seniors in the minor to use alternative course options for the frequently over-enrolled/waitlisted courses in the minor (FILMSTD 4800 and THEATRE 5331, and those offered once per year (FILMSTD 4800, 4890).
- Streamlining course options in the minor will reduce time-to-degree issues minors face, and boost enrollment in
 the current slate of Screenwriting classes (taken by Screenwriting minors, Film Studies majors with screenwriting
 upper-level focus area, English and Communication majors and minors, and students using these courses as
 electives for TFMA programs including the MIP-BA, Video Arts minor, and Film Studies minor). Students would
 still be required to meet the existing prerequisites for each of the courses in the minor, but the change
 redistributes enrollment to avoid logjams at the introductory and advanced points of the curriculum and redirects
 enrollment to available seats for courses more regularly offered (FILMSTD 4880, 4881).

There are no additional instructional needs or credit hour changes to the minor as a result of proposed changes. There are no amendments needed to program assessment design or data collection as a result of these changes.

Effective date: changes to the minor would be effective for incoming and current students, with immediate implementation following CAA approval.
