I am writing to inform you that the John Glenn College supports the creation of a 3a Stand Alone and 3b Embedded Graduate Academic Certificate in Nonprofit Management. In an electronic vote that concluded April 19, 2024, the College faculty voted unanimously in favor of creating this certificate.

This proposed 12 credit hour certificate will be an attractive stand-alone certificate option for professionals who need to build nonprofit management skills but who are not yet ready or who are not interested in a full master's degree. The credential should be valuable for career advancement. The embedded certificate provides Glenn College MPA students, who are not eligible to take our existing 10 credit hour minor, an opportunity to earn a nonprofit credential. For advising purposes and simplicity, we are simultaneously proposing a few small changes to the curriculum of the minor to largely mirror the curriculum of the certificate.

Enclosed, you will find a letter from our Director of Graduate Professional Studies, Jim Landers, the Curriculum Proposal Checklist, the Registrar sheets, the signed MOU with OSO, and the certificate proposal. We are separately submitting our proposal to modify the existing nonprofit minor.

Dear Dr. Stromberger:

I am writing to inform you that on February 14, 2024, the Glenn College Graduate Studies Committee voted to move forward with the proposal for a new embedded and stand-alone certificate in Nonprofit Management.

The Glenn College's ranking and expertise in the field of nonprofit management has improved markedly in recent years. What's more, a recent alumni survey indicated that 16% of graduates with a Glenn master's degree currently work for a nonprofit organization, exceeding all other sectors but state government and higher education. While the market analysis indicates that national competitor MPA programs offer concentrations or specializations in nonprofit management, the Glenn College offers no such program. The committee believes that the embedded certificate would encourage more Glenn College MPA students to enroll in nonprofit management courses and specialize in the field and the stand-alone certificate would enhance the reach of the Glenn College's programming to students in other programs on campus as well as working professionals currently not enrolled at Ohio State.

We believe that these changes will further enhance the reputation of the Glenn College, improve student experience, and provide benefits to the community due to the improved skills and knowledge of matriculants moving into the nonprofit sector.

Program Overview

The John Glenn College proposes a new embedded and stand-alone graduate certificate on "Nonprofit Management." The certificate is a 12-credit hour program, designed to equip individuals with the specialized knowledge and skills needed to lead and manage nonprofit organizations effectively.

The certificate is a natural evolution for the existing nonprofit management curriculum given that a graduate minor exists but is not an option for Glenn College students or those outside the university. Designed to be a flexible program, it could be completed with careful planning in as little as three semesters (one calendar year) either in person, online, or some combination of the two.

The program caters to professionals seeking to advance their careers in the nonprofit sector as well as those looking to transition into this field. Through a comprehensive curriculum, students explore key areas such as governance, financial management, advocacy, marketing, fundraising, and grantwriting. This program is ideal for those who wish to make a significant impact in the nonprofit world, providing them with the tools to drive organizational success and societal change.

Program Rationale

The Glenn College is <u>now ranked #11 in Nonprofit Management</u> by the U.S. News & World Report, up from #17 just two years ago. We now have four <u>core tenure-track</u> <u>nonprofit faculty</u> members (Beaton, LePere-Schloop, Tran, Wilson). These faculty compose the Glenn College Nonprofit Studies Committee, which oversees the nonprofit curriculum at the undergraduate and graduate levels. It is this committee that initiated the present certificate proposal.

The Nonprofit Studies Committee pays close attention to the needs and interests of Glenn College students. As part of our program assessment, we conduct the Glenn College

Alumni Survey; in the 2022 survey, of the respondents who had completed a Glenn master's degree (n=146), 16% of respondents said they are currently working in a nonprofit organization (other than a university). The same percentage (16%) work in state government, and the only sector with a higher percentage was higher education (34%).

Despite the Glenn College's growing nonprofit expertise and the interest among students, our master's nonprofit curriculum is sub-par compared to our competitors. Our top national nonprofit competitor is Indiana University (IU; ranked #1 in both public administration and nonprofit), which requires that its master's students adopt a concentration – among them is Nonprofit Management. Many other national competitors have a similar structure, though the concentration/specialization/area of study is often optional. (See Table 1 in the Comparative Program Analysis section.)

Without such a nonprofit credential in the Glenn College to organize and incentivize students into a nonprofit track of study, it is challenging to fully enroll and, therefore, consistently offer nonprofit courses. This is especially a problem as we attempt to grow online offerings for our online master's students but also try to maintain an in-person program. Evidence of this problem can be seen in enrollments of our core nonprofit course (7553), which was canceled in Spring 2023 due to low enrollment and only had 7 students enrolled in Autumn 2023. Additional evidence of the problem is the wide swath of students favoring the Nonprofit Projects Capstone (7950) but have never taken any of our nonprofit courses despite being advised to do so.

The new embedded graduate certificate in nonprofit management will serve existing Glenn College master's students by offering them a credential for taking a series of nonprofit courses. The addition of the standalone certificate also enables students outside the Glenn College to gain a credential. While we already have a graduate minor for non-Glenn OSU students, we may find that these students prefer a certificate to a minor. The standalone certificate will also enable us to enroll non-OSU students. The combination of these audiences will, as mentioned, allow us to more fully enroll in our core nonprofit courses, offering each of them at least once a year in both an in-person and online format.


Given this background, the certificate is designed to be as flexible as possible to maximize enrollments while limiting resource input. Because the graduate nonprofit curriculum already exists (all courses received concurrence at the time of their creation) and is being offered, this proposal is a matter of packaging the current curriculum into a new credential. Therefore, the resources required are minimal. No course development is necessary, and the Glenn College accrediting body (NASPAA) does not accredit certificates. Therefore, the only resources necessary are those from student services to enroll students.


Comparative Program Analysis

Research shows that nonprofit jobs in the United States have consistently grown over the

past decades and that the nonprofit sector is most immune to external shocks. For instance, <u>a report on nonprofit employment</u> shows that from 2007-2017, nonprofit employment grew 18.6% while for-profit employment only grew 6.2%. According to the <u>Bureau of Labor</u> <u>Statistics</u>, following the pandemic, the nonprofit sector was able to regain the number of jobs before the pandemic at a faster rate than the business sector. This job growth is partly driven by the ongoing growth of the number of nonprofit organizations in the U.S.

In January 2020, Glenn College acquired a feasibility study on the creation of a graduate certificate in nonprofit management. The study concluded that there are many similar programs available, but the demand for professionals with nonprofit credentials is high.

Certificate Learning Objectives & Assessment

The Nonprofit Management Certificate is designed to meet the needs of those who are: 1) John Glenn master's students who seek a credential in nonprofit management because they are interested in working for or with nonprofits following graduation; 2) OSU master's students from other colleges and departments who are interested in working for or with nonprofit practitioners who currently work in nonprofit organizations, but seek a credential to formalize their training.

The Graduate Certificate in Nonprofit Management is designed to achieve three Expected Learning Outcomes (ELOs). Upon successful completion, students will be able to:

- Manage and lead nonprofit organizations towards goals.
- Understand nonprofit organizations as a unit of analysis.
- Identify and manage internal and external challenges to nonprofit organizational performance.
- Engage in strategic planning for nonprofit organizations.

The certificate will be evaluated on an ongoing basis. The three metrics below will be used to assess the certificate program in general and the learning outcomes more specifically. We will determine if students are meeting the ELOs and if improvements could be made to strengthen the assessment tools and practices, course content and/or delivery, and assignments that align with the certificate learning outcomes.

- Enrollment and completion rates will be tracked over time. Please see Table 6 for enrollment projections. We expect at least a 75% completion rate overall. Because the certificate populations considered in this proposal are often nontraditional (i.e., working professionals), there is no time limit on the completion rate. The certificate may be completed in as little as a year but may take longer for individuals pursuing it part-time.
- 2. In the two core courses, certificate ELOs are pegged to assignments (or parts of assignments) and rubrics. These rubrics are included in the assignment grading component in Carmen Canvas.
- 3. Student Evaluations of Instruction (SEIs) will be conducted at the end of each certificate course and examined on an annual basis. Actions to improve inputs, such as improvements in delivery, content, assignment structure, and/or assessment measures, will be identified, and recommendations to instructors will be made for the following cycle.

Curriculum

The Nonprofit Management Certificate is designed to meet the needs of those who are interested in working for or with nonprofits following graduation. It is a 12-credit certificate. All students are required to take the two foundational courses on nonprofit

governance and finance. These are core to nonprofit curricula across the field. Both core courses will be available in person and online regularly.

Students must then take five additional credits. The Glenn College offers a variety of more specialized courses relevant to nonprofit management, including courses on advocacy, fundraising, and marketing. We offer an upper-level nonprofit research seminar that covers academic research on nonprofit management. A capstone course is also available where students engage in a consulting project for a nonprofit organization in the Columbus area. Finally, we have included two one-credit skills courses relevant to nonprofit management because the credit configuration of the core courses is such that students may be missing just 1 credit by the end of the program.

All these courses currently exist and have been taught before. Glenn College faculty or instructors with professional experience in the nonprofit field teach them. The Glenn

College Nonprofit Studies Committee is dedicated to continuing to enhance the curriculum. For instance, there are plans to convert some of these in-person-only courses to online and for the creation of nonprofit-specific one-credit skills courses on topics like volunteer coordination and board development.

Eligibility

Current OSU Students (embedded certificate, 3b)

Admission to, performance in, and exit standards for the embedded certificate are consistent with the Graduate School's standards for admission and progression. Embedded certificate students will have been initially admitted to the university as part of a graduate degree program (either the Glenn College or another College on campus). The Glenn College will provide secondary admission to the certificate program for any OSU student applying who has a minimum cumulative GPA of 3.0 (on a 4.0 scale or equivalent) in their graduate degree program. A personal statement and a transcript are required from all applicants.

A minimum cumulative GPA of 3.0 is required to receive a certificate, and only grades of A through C- may be counted toward the completion of the certificate program. Allowed overlap between the proposed certificate and the student's degree program is 100%.

Non-OSU Students (standalone certificate, 3a)

Admission to, performance in, and exit standards for the standalone certificate are consistent with the Graduate School's standards for admission and progression. Admission requirements include a baccalaureate degree from an accredited institution with a minimum cumulative GPA of 3.0 (on a 4.0 scale or equivalent) for the last bachelor's or advanced degree earned. Personal statements require articulation of how the certificate is consistent with the applicant's professional and career goals. Students from international undergraduate institutions are recommended to score at least 100 in the TOEFL iBT. Resumes and transcripts are required from all applicants.

A minimum cumulative GPA of 3.0 is required to receive a certificate, and only grades of A through C- may be counted toward the completion of the certificate program.

Administrative Arrangements

Marketing & Recruitment

As part of an agreement with Glenn College, ODTI would market the proposed certificate with supplemental funding from Glenn College. Typically, ODTI works with the departments and colleges to create a strategic marketing plan, which includes additional marketing efforts carried out the Glenn College. The Glenn College employs a director of

marketing and communications (Erin Trueman) as well as a graphic designer (Majesti Brown). These two individuals will be of great support in marketing the program inside and outside of OSU.

Admissions and Advising

Recruitment and Admissions for students enrolling in the proposed certificate will be administered by the Glenn College student services staff. Advising and student support for students enrolling in the certificate will be provided by the Glenn College. The Glenn College employs an academic advisor dedicated to graduate students (Vivian Ballón) and an online program manager (Mindy Niehaus). These individuals would be responsible for working with students enrolled.

The Glenn College also employs a career and internship specialist (Jim Ellison), who is well-networked within the nonprofit community. He is well equipped to provide support to students seeking to practice in the nonprofit sector.

Efforts to Enroll & Retain Underrepresented Groups

As with all our programs, we will make concerted efforts to attract and retain underrepresented groups. Through targeted marketing to specialized groups, we look forward to reaching prospective students from various underrepresented backgrounds, broadly defined. The ability to complete the certificate online as a standalone will also allow us to reach a population that we cannot currently service.

Our retention efforts will continue to be characterized by professional competence with a personal touch. Our advisors regularly reach out to underrepresented students (a typically "at risk" group for attrition) to check in and make sure their needs are being met. We also have a standing College Diversity Committee and a student organization that serves those interested in multicultural affairs (the Public Affairs Multicultural Student Organization – PAMSO). In addition, all students will have access to our career services office.

Tuition and Student Fees

Tuition and fee assessments follow OSU standards.

Projected Enrollment

The Nonprofit Management Certificate expects a ramp-up in enrollments over the next 5 years based on the populations served. Ultimately, we hope to enroll approximately 10 new Glenn Master's students, 4 new non-Glenn OSU students, and 6 new non-OSU nonprofit practitioners in the certificate each year. If the average time to completion is 1.5 years, we should enroll a running average of approximately 25-30 students each year.

Rationale: The Glenn College's ranking and expertise in the field of nonprofit management has improved markedly in recent years. What's more, a recent alumni survey indicated that 16% of graduates with a Glenn master's degree currently work for a nonprofit organization, exceeding all other sectors but state government and higher education. While the market analysis indicates that national competitor MPA programs offer concentrations or specializations in nonprofit management, the Glenn College offers no such program. The committee believes that the stand-alone certificate would enhance the reach of the Glenn College's programming to students in other programs on campus as well as working professionals currently not enrolled at Ohio State.

Proposal to Revise the Graduate Nonprofit Management Minor

John Glenn College of Public Affairs

Background: New Nonprofit Management Certificate

The Glenn College is <u>now ranked #11 in Nonprofit Management</u> by the U.S. News & World Report. Despite the Glenn College's nonprofit expertise and the interest among students, our master's nonprofit curriculum is sub-par compared to our competitors because we do not currently offer a Nonprofit Management credential to Glenn College master's students. To address this gap, under separate cover, the Glenn College Nonprofit Studies Committee has proposed a Nonprofit Management certificate (embedded and standalone). Because non-Glenn students may choose to take the new certificate instead of the minor, this leaves us with the decision of whether to retire the minor.

Rationale: Complementing the New Certificate

For the time being, we propose keeping the minor alongside the certificate. The purpose of the embedded certificate is to cater to current Glenn master's students. While master's students outside of Glenn can earn the certificate, traditionally, they have enrolled in the minor. We do not want to disrupt that option. Further, the minor requires 10 credits whereas the certificate will require 12 credits, making the minor appealing. If non-Glenn students demonstrate a preference for the certificate over the next one to two years (minimal minor enrollments), at that point, we will propose phasing it out.

Though we would like to keep both for now, for advising purposes and simplicity, the certificate and minor should be very similar, which requires changes to the minor. Here is an overview of the changes:

- Compared to the certificate: The only difference between the proposed certificate and the revised minor (below) is the certificate includes two additional 1-credit hour course options under the specialized courses category. These 1-credit options are important for the certificate because of its 12 (vs. 10) credit requirement.
- Compared to the existing minor:
 - Foundational Courses
 - PUBAFRS 7553 Nonprofit Financial Management has been moved to the required list from the specialized list. This course is fundamental to nonprofit management and is now being offered frequently enough that it will not prohibit minor completion.
 - Some specialized courses have been replaced by new course offerings that are more specific to the nonprofit (as opposed to the public affairs) field.
 - Adding
 - PUBAFRS 5120: Social Change Advocacy: Organization, Mobilization, and Activism (3) (New course offered for the first time in SP24)
 - PUBAFRS 5520: Board Development (1) (Skills class that we are now getting a permanent number for)
 - PUBAFRS 7950: Capstone: Nonprofit Projects (3) (A valuable experiential course)
 - Removing
 - PUBAFRS 5591: Lobbying and Government Relations (3) (PUBAFRS 5120 is more relevant for the minor. Students could still seek permission to include PUBAFRS 5591 if it makes sense for their career paths.)

- PUBAFRS 5595: Social Enterprise (3) (Not a core nonprofit course. Students could still seek permission to include PUBAFRS 5595 if it makes sense for their career paths.)
- PUBAFRS 6080: Concepts and Methods of Program Evaluation (4) (The course has a prerequisite requirement, thus creating a stealth prerequisite for the minor)

Transition Plan

We propose implementing these curricular changes beginning Autumn 2024. The transition policy is as follows:

- Students declaring the minor Autumn 2024 or later would be held to the standards of the new policy minor requirements.
- Current students in the minor will be converted to the new requirements, but course substitutions will be made on a case-by-case basis to ensure that no student's time to completion of the minor is negatively impacted by the changes. Students will be encouraged to work with their advisors to determine the best path through the minor.

Learning Goals and Assessment

No changes. Below are the learning goals from the original proposal for the minor in 2015.

Upon successful completion of the Graduate Minor in Nonprofit Studies, students will be able to:

- Describe the theories and practices that shape political, organizational, economic, and technological environments of nonprofit organizations
- Apply these theories to analyze nonprofit management dilemmas from a strategic perspective, grounded in awareness of nonprofit laws, standards, and best practices
- Function effectively in accordance with the goals and missions of a variety of stakeholders from the nonprofit, public, and private sectors, utilizing both written and oral communication skills.
